## PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020

#### RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

### This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

I would like development options OP1 and OP2 deleted from the LDP for Potterton, or at the very least significantly restricted so that only a small number of houses may be built.

#### Reason for change:

#### 2. Need for development of this scale

There is no need for a development of this scale at this location. The Land Audit has established that there is currently 7.2 years of available housing in the Aberdeen area. Historically there has been increasing demand for housing, driven in large part by the oil and gas (O&G) industry. As shown by falling house prices however, since 2014 that has no longer been the case and demand for housing will continue to be suppressed by the contraction of the O&G business in a world increasingly concerned by carbon emissions. In addition to this are the the effects of the current drop in oil prices and the economic disruption caused by COVID-19 and Brexit. The lack of demand for new houses that have recently been built is evidence of the falling demand and therefore lack of need.
