

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



LDP 2021 Appendix 7C Potterton:

I would like development options OP1 and OP2 deleted from the LDP for Potterton, or at the very least significantly restricted so that only a small number of houses may be built.

(I have submitted 9 separate points by way of justification).

Reason for change:

4. Traffic and road conditions

Neither Manse Road (Potterton to Milton of Potterton) nor the C1C (Belhelvie to Blackdog) are suitable for the additional 100's of vehicles that OP1 & 2 would bring. These roads are narrow (effectively single track in places) and include a blind summit and several sharp bends, and the junction between them at Milton of Potterton is very poorly sighted. Even with existing traffic, every day there are occasions when avoiding action needs to be taken, particularly when cars meet buses, tractors or HGVs (and there are more HGVs on the road now that the AWPR is open). The junction at Milton of Potterton is particularly difficult for traffic on the C1C: south-bound traffic turning into Potterton is almost blind, north-bound traffic (particularly larger vehicles) has to swing on to the wrong side of the road - on a blind bend - to make what is a very sharp turn.

The Transportation Note within the MIR prepared on behalf of the proposed developer lacks credibility as it fails to reflect the actual condition of the roads around OP1 & 2.

The limited bus service to Potterton (see point 5) means that residents of OP1 or 2 would largely be compelled to drive.

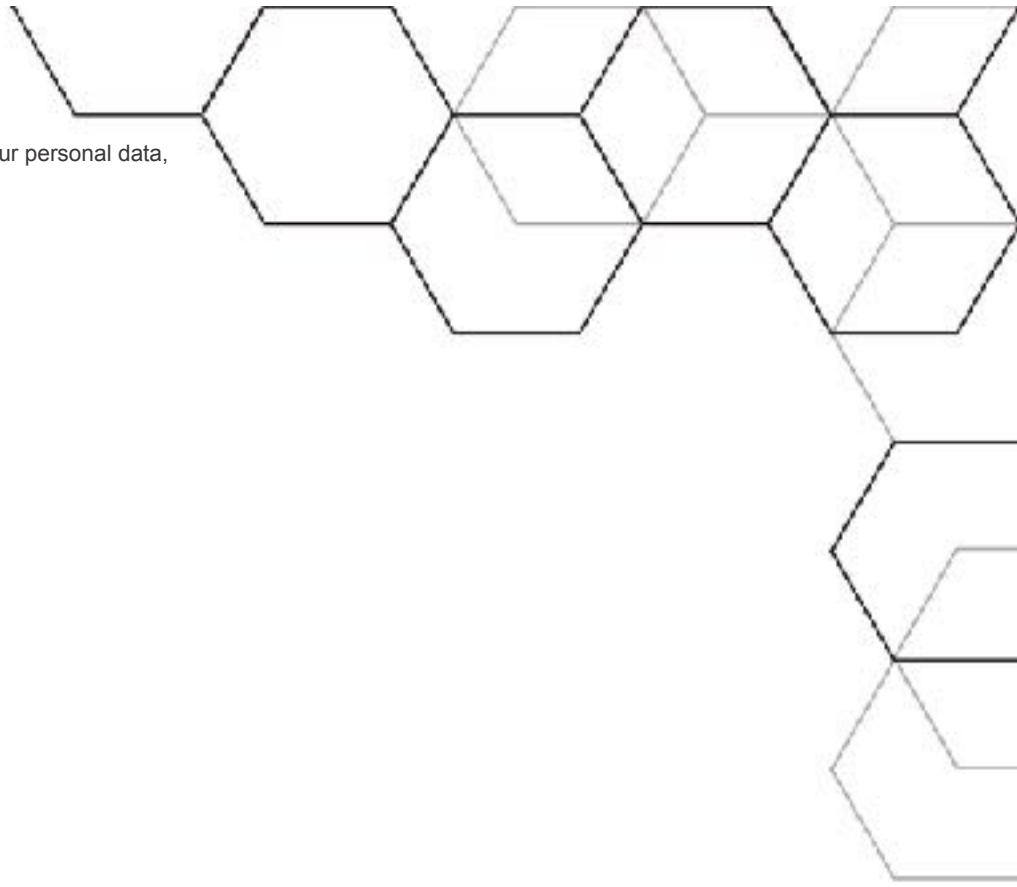

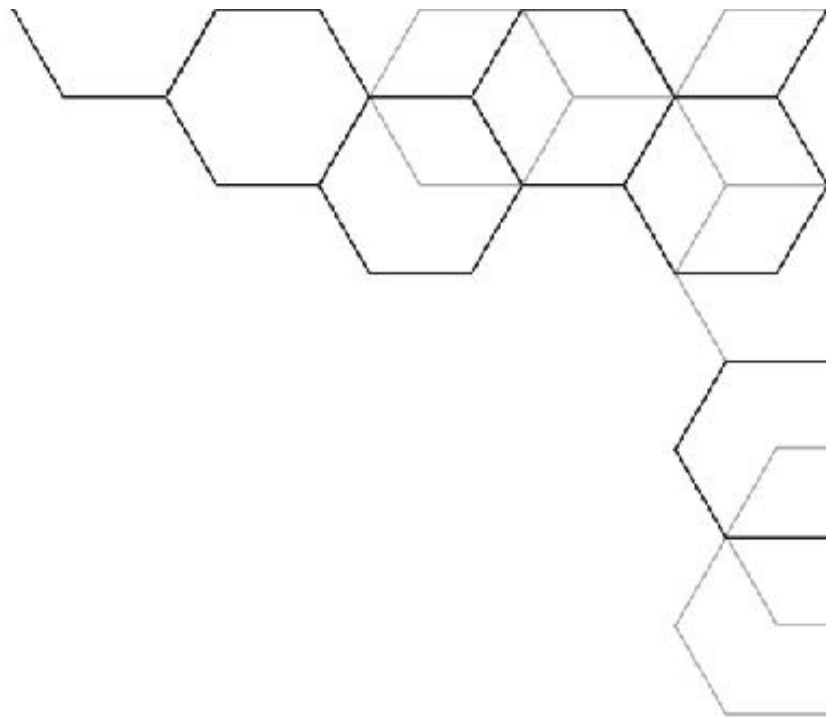
