

RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.


This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Removal of development plan for OP1 in Luthermuir, Kincardine & Mearns	

Reason for change:

- Current infrastructure would not be able to support this i.e. the narrow country roads would not be able to cope with increased volume of traffic
- There are no local shops
- There are limited amenities to support extending the village
- There are very limited local employment opportunities
- This would result in loss of prime agricultural land
- This would increase noise pollution to nearby residents
- A housing development of this nature would be detrimental to the character of the village
- This development offers no benefit to the historical environment
- There would be destruction and loss of several well-established trees and wildlife (red squirrels have been sighted). Also, destruction of well-established hedge
- It is understood that there is a tree preservation order on the access drive to
- The proximity of the development to 2 listed buildings would be detrimental to the character and surrounding area of the listed buildings, and the quality of life of the people who live there
- Current bus timetable is not adequate to support additional residents in a rural village
- There is insufficient broadband available to accommodate this development as people who have recently moved to the village have struggled to get this installed
