# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

# This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

### LDP2021NN

I would like to object to the proposed local development plan for the changes in Potterton. This current development plan opens up the village to a mass of development/housing which is unsuitable to the area and the green belt that surrounds the village. I object to OP1, OP2 and the destruction of the green belt.

### Reason for change:

Lack of infrastructure and Community facilities

The current road around Potterton could not sustain an increase in traffic/vehicles that this proposed development/housing would bring to the village. The transportation note within the Main Issues Report was completed by **Sectors** on behalf of the developer of OP1/OP2. Based on their findings, Potterton has an average of 1.7 cars per household. On that assumption. It would be an additional 396+ cars. They consider this to have no impact! There would also be construction traffic to add to this. This would indeed have a detrimental impact on the village of Potterton. Access points off of Denview Road into the proposed OP1/OP2 sites would create a huge increase in the volume of traffic on a quiet road/cul-de-sac where children play and dogs are walked.

Scottish Water are already aware that there is a high water table at Potterton with current ongoing issues with drainage and run off, which the pumping station cannot cope with. Additional development would put further strain on this, and not be suitable in the sites noted as OP1/OP2 in the proposed local development plan.

Schooling - Balmedie Primary is already nearly at capacity, its been predicted that in the next 5 years it will be at 118% capacity, this needs to be addressed before any new development and further housing in this area should be considered in this area and the Balmedie Primary catchment area.

There is no provision in this plan for increased amenities within the village of Potterton. Current schools, roads, and infrastructure could not support development.

#### Destruction of Green Belt

Would be very disappointing to see the green belt around the village of Potterton disappear, this is valued green space enjoyed by the residents of the village. Our environment and wildlife will suffer the impact. Our beautiful ancient woodland is home to some important biodiversity and is being put at risk of preservation.

I personally stand to lose privacy in my home as will be directly overlooked by OP1/OP2 as is the case with many neighbours and friends who live in this community.

Planning documents claim that there is 'no sense of place' and a 'lack of identity' in our

village which is simply untrue, I grew up in this village and moved back with my own family and wife 16 years ago as it's a beautiful, safe, unspoiled village with a strong community spirit. Our committee regularly organise events all year round for the village which many of us regularly participate in, including monthly pop cafes, gardening projects, maintenance projects to keep our village looking beautiful – this shows that we do indeed have a community here in Potterton and the residents value it and take pride in it.
