

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

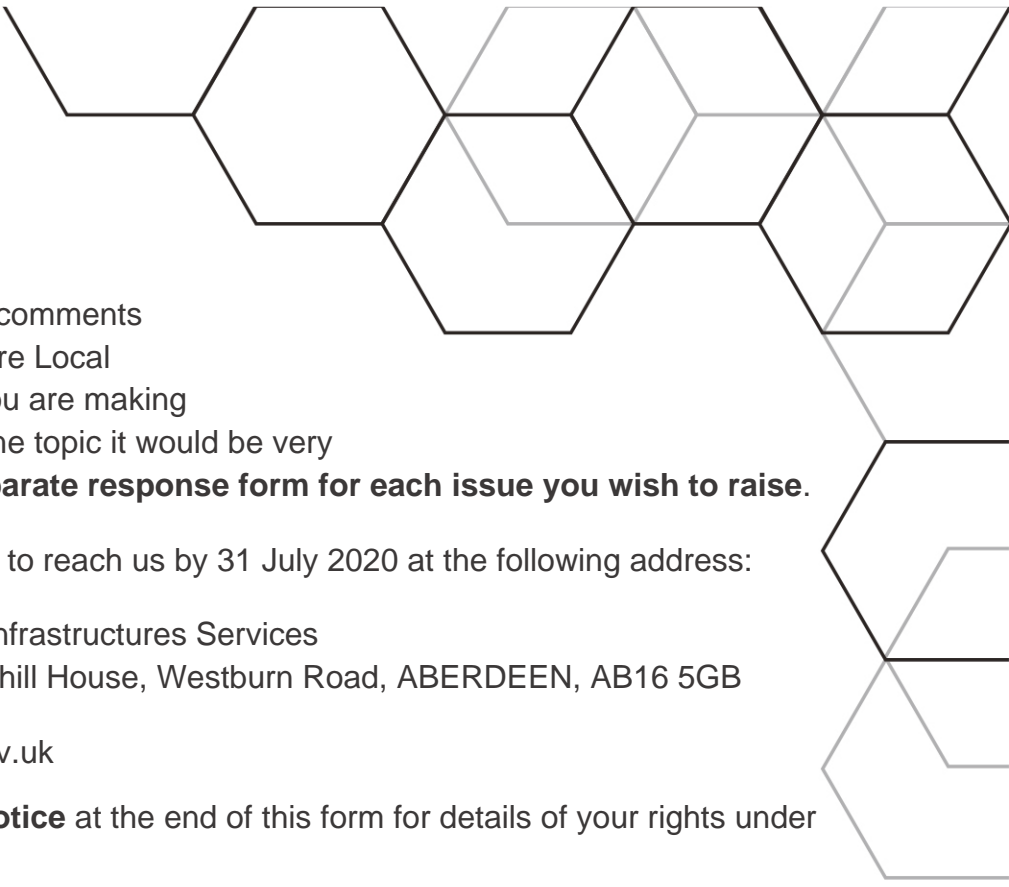

R1 in Blackburn, Garioch

For allotments/ community growth space.

Reason for change:

The proposal within the development plan shows an area of community land to be redeveloped for allotments and community growth space. I must submit my objection to this as a resident of Averon Park on many fronts.

Parking and through traffic on Averon Park and Den View is at a premium. There is not sufficient parking for existing residents and visitors let alone the constant movement of users of the allotments. As you will know both streets are cul-de-sacs with no through access and, as such, even if traffic was to be used to drop off and deliver, the management of the traffic to maintain access would become very difficult and problematic for all residents and residents' visitors. In addition, there is a significant number of small children in the streets of which increase in traffic flow will cause increased risk to their safety. One accident is always one too many.

The land in question is well used by the community from young to old. Families are often seen playing together, grandparents with Grandchildren, exercising of pets and generally walking and taking exercise. Children's playgroups to elderly amblers. The land is for the community and is used by the community. To change the use would deny the many for the benefit of the few.

I am concerned by the ground conditions in the area. In wet days the grass can become very soft and there has been occasions that unsupported soil has washed into gardens causing significant damage. This is why the paths had to be tarred. To remove the grass and return to topsoil would undermine the support from the grass and allow the top surface to be washed downwards causing once again substantial damage.

I am not against allotments as they are good for exercise, well being and mental health but I cannot support the location chosen here and must raise these concerns with the council.
