

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Reason for change:

I and my family object to the above plans for development at Potterton due to the following reasons;

- Losing our green space as a healthy and peaceful environment to live,
- Increased traffic and congestion with no infrastructure to cope with this. (A potential additional 400+ cars is dangerous to all who live here as well as the environment)
- Overcrowding the area with risk of crime and safety issues for our Children and Elderly who enjoy the open spaces as a currently safe place to be and enjoy our homes, gardens and surrounding areas to exercise, relax, improve mental health and grow up and grow old in a healthy and secure environment - this will be affected with change in 60% increase in housing.
- There is no plan for increased amenities in the village
- Current Schools are already at capacity with School Transport being an issue that more buses would be needed and the Schools would need extended or further Schools built - not prepared to cope with an increase in families moving to the area.
- No proven need to lose Greenbelt area for this development and suffocate an existing village that serves its community well as it stands.
- Long term development of up to 5 years for building this proposal will affect and disrupt the community significantly with construction traffic, pollution, noise and making it a less safe place to live.
- Our property will be devalued with an increase in housing and insurances rise as currently we are deemed one of the safest places to live which will change with an increased risk due to almost doubling the village in size.

Due to the above reasons we strongly object to our ideal place to live being ruined by such a plan to increase the size of the area as proposed.
