

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



LDP2021NN - POTTERTON (Appendix 7C)

I would like to strongly OBJECT to the proposed housing development in Potterton within the LDP. I would like the development options OP1 & OP2 removed from the plan (or at the very least, SIGNIFICANTLY restricted to a small number of houses) in order to maintain the separate characters of the Milton of Potterton settlement & Potterton village, to preserve the green belt and to protect the local (rural C-class) road network.

As requested, I am submitting separate response forms for each issue raised; total 6.

Reason for change:

1. IMPACT ON CHARACTER OF MILTON OF POTTERTON & POTTERTON

The proposed development of OP1 & OP2 (~233 houses) will change the size of Potterton village by well over 50% which by any reckoning is an unacceptable & unsuitable increase in size for any village community. Such an increase would completely change the character & landscape of the village. It should be remembered that Milton of Potterton & Potterton residents chose to live in a small village.

Also and significantly for a Milton of Potterton resident, this development would effectively absorb Milton of Potterton into Potterton. Whilst I enjoy living close to the village and benefit from its sense of community, my neighbours & I chose to live in a small & distinct settlement which has a separate identity to Potterton; Milton of Potterton would be 'lost' if this development was to go ahead.

The Main Issue Report (MIR) states that the development of FR141A & FR141B (120 houses) 'may be too big at this time for the village'; therefore, a development of over 230 houses is definitely too big. It also said that 'the planning objective for the settlement is to preserve the amenity of the village'. The development of OP1 & OP2 is contrary to this planning objective.

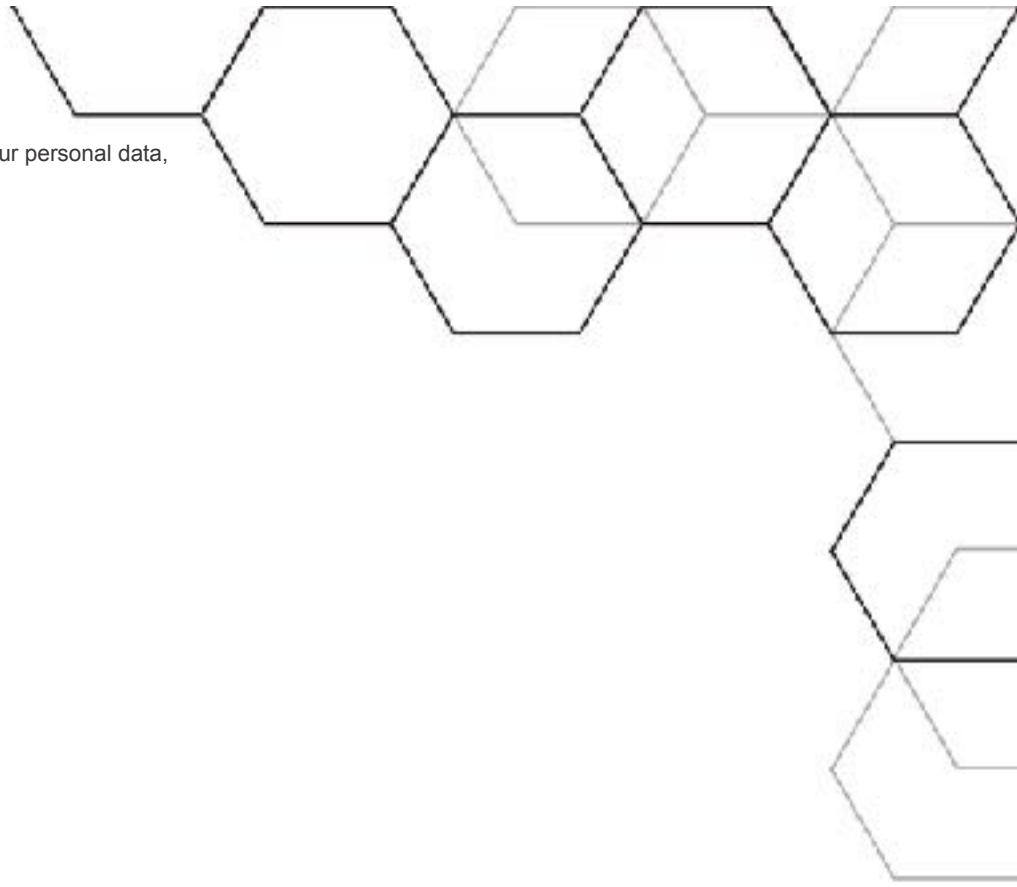

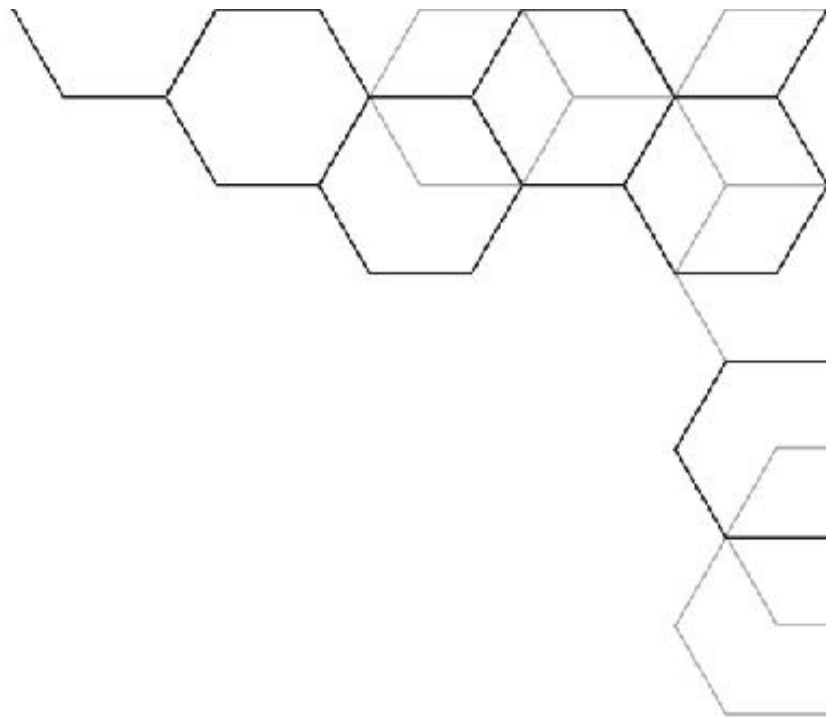
