

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



LDP2021NN - POTTERTON (Appendix 7C)

I would like to strongly OBJECT to the proposed housing development in Potterton within the LDP. I would like the development options OP1 & OP2 removed from the plan (or at the very least, SIGNIFICANTLY restricted to a small number of houses) in order to maintain the separate characters of the Milton of Potterton settlement & Potterton village, to preserve the green belt and to protect the local (rural C-class) road network.

As requested, I am submitting separate response forms for each issue raised; total 6.

## Reason for change:

### 4. NEED FOR DEVELOPMENT/HOUSING LAND SUPPLY

Given the (pre-Covid 19) economic downturn in the northeast together with the 2019 Housing Land Audit's established view that there is currently 7.2 years of available housing in the Aberdeen area, there is no need for a development of this scale at this location at this time. The loss of designated green belt land cannot be justified by 'housing need'.

House demand, therefore prices, in the northeast are greatly driven by the 'health' of the Oil & Gas Industry. Houses prices here have been falling since 2014 so the demand is not there and is likely to be increasingly so with the ongoing contraction of the Oil & Gas sector, the current drop in oil price and the unknown (but likely to be negative) economic impact of Brexit & Covid 19.

House building in developments that have already been approved are NOT being built due to lack of demand which is evidence of a lack of need for OP1 & OP2 development (or development of 'reserved' status sites).

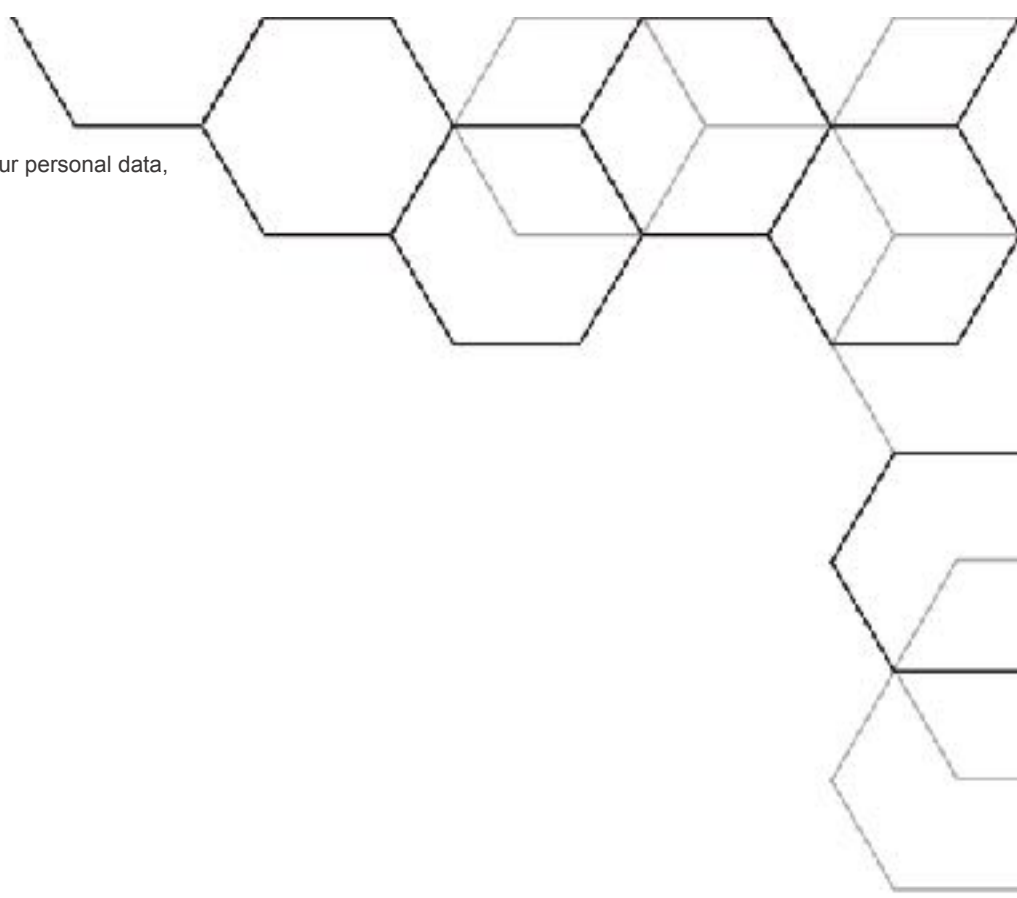

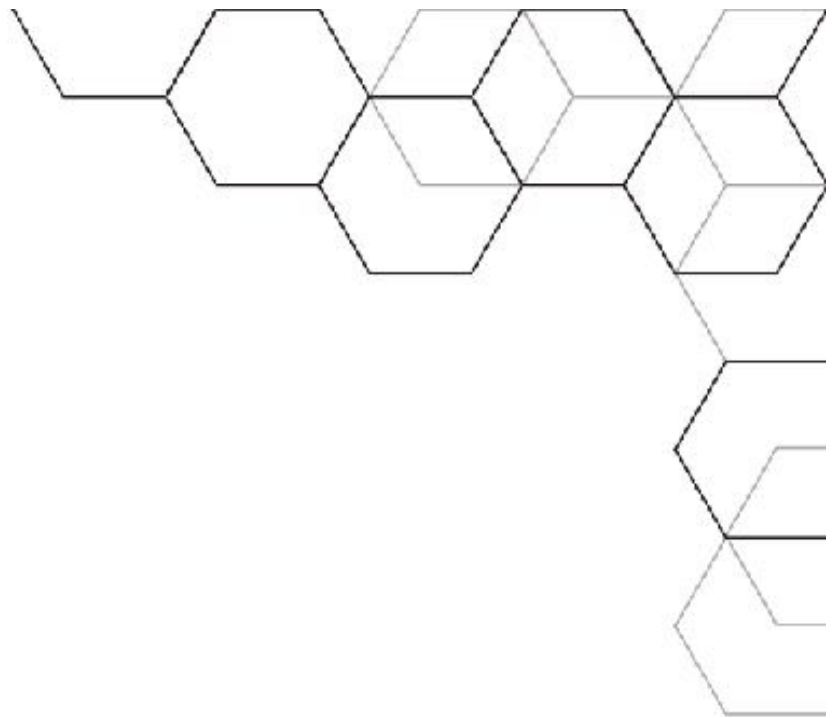
