

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



LDP2021NN - POTTERTON (Appendix 7C)

I would like to strongly OBJECT to the proposed housing development in Potterton within the LDP. I would like the development options OP1 & OP2 removed from the plan (or at the very least, SIGNIFICANTLY restricted to a small number of houses) in order to maintain the separate characters of the Milton of Potterton settlement & Potterton village, to preserve the green belt and to protect the local (rural C-class) road network.

As requested, I am submitting separate response forms for each issue raised; total 6.

Reason for change:

5. FLOOD RISK/LACK OF SEWAGE & DRAINAGE CAPACITY

The LDP states that parts of the OP1 & OP2 are within SEPA-assessed flood risk areas indicating the inappropriateness of developing these areas, especially when other non-flood plain areas are available in the area.

The LPD acknowledges that there is insufficient capacity at Balmedie Waste Water Treatment Works to treat all proposed development sites in the catchment area; it does not have the capacity for the OP1 & OP2 developments.

The upgraded water treatment plant for Potterton (sited in Milton of Potterton) allowed for selected small development in the village only. After heavy rain with increased run-off from the fields & roads, Potterton Burn can become contaminated and this has been attributed to blocked pump filters at this pumping station on a number of occasions. My house is located opposite this small plant and I can attest to the increased noise from the pumps when they are not working efficiently.

These water treatment facilities cannot cope with increased demand so Milton of Potterton & Potterton are at risk of increased environmental contamination if development of the proposed scale is allowed.

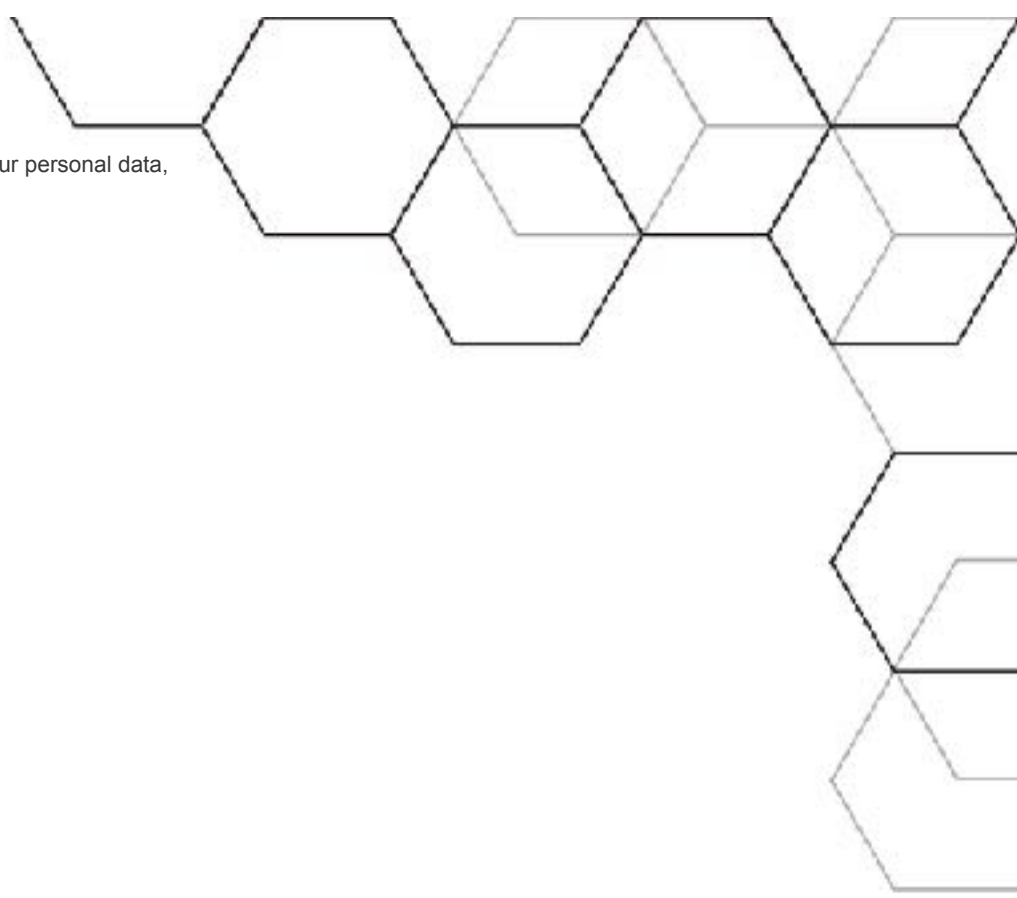

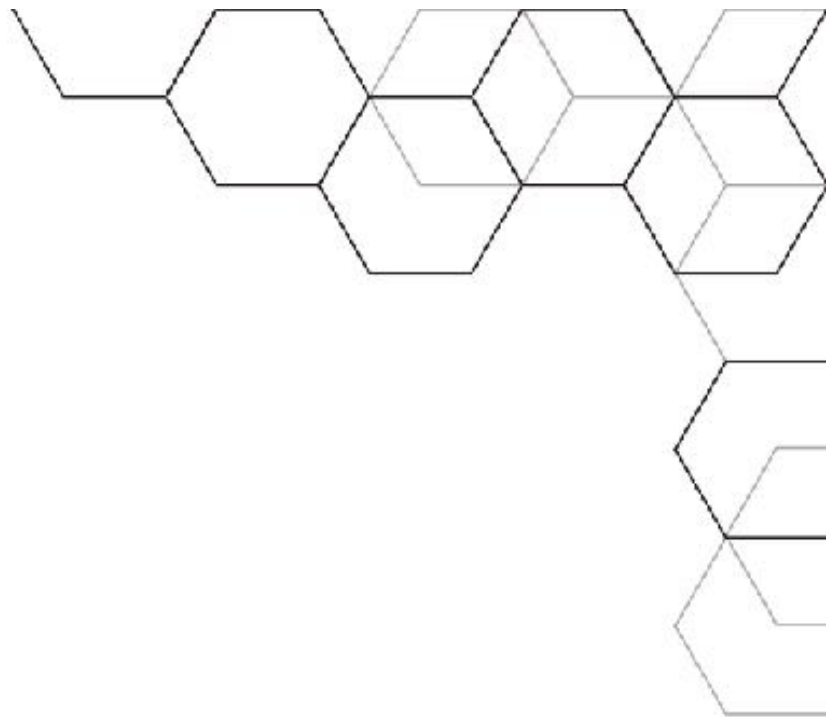
