## PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

# This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Project moved away from West of Deeside Brae estate (Leggart Brae) and moved to the South adjoining Deeside Brae development and running parallel to the main Aberdeen>Stonehaven A92 road by which time the development can have a road that could be built to feed in to the A92 as opposed to the B9077 running parallel with the River Dee

#### Reason for change:

The building of the Deeside Brae estate has already put major pressure on the Old Bridge of Dee traffic blackspot, tenants of the original Leggart Estate have serious problems leaving the estate to join the B9077 in the morning traffic is usually backed up to way past the exit road of Deeside Brae estate, the roundabout at the Bridge of Dee has a constant stream of traffic arriving from the South making feeding in to the traffic from the less busy (but backed up) B9077 extremely difficult and dangerous as the stream of traffic on the A92 rarely lets up long enough to allow build up pressure on the B9077 to release.

On a purely recreational note Tollohill Wood is the only green space available to Leggart and Deeside Brae residents within safe (ish) walking distance for dog walking or to enjoy peace and solitude from the city, the additional traffic created by the new development proposed will put pressure on the feeder road to the B9077 making it more dangerous to walk.
