PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

MAIN ISSUES REPORT FORMARTINE. PAGE 84 - FR140

Reason for change:

THE LDP ADMITS THERE IS INSUFFICIENT SEWAGE CAPACITY FOR THE PROPOSED SITES.

THE LACK OF PUBLIC INFRASTRUCTURE (BUSES) WOULD INCREASE TRAFFIC ON BOTH C CLASS ROADS TO THE NORTH. THE C CLASS ROAD FROM BLACKDOG ROUNDABOUT TO POTTERTON HAS MULTIPLE 'PINCH POINTS' WHERE MEETING ANOTHER CAR FORCES BOTH TO STOP. BUSES AND TRACTORS ALSO FREQUENT THESE ROADS.

ADDING POTENTIALLY 200-400 CARS THAT USE THESE ROADS WOULD BE DANGEROUS.

IN THE MAIN ISSUES REPORT IT MENTIONS EXTENDING DENVIEW ROAD TO THE AWPR. THIS CANNOT BE A SERIOUS OPTION. ROUTING HUNDREDS OF CARS THROUGH THIS ROAD WOULD BE SERIOUSLY DANGEROUS.

Main Issues Report Formartine. Page 84 – FR140

Reason for change:

The LDP admits there is insufficient sewage capacity for the proposed sites.

The lack of public infrastructure (buses) would increase traffic on both C class roads to the North.

The C class road from Blackdog roundabout to Potterton has multiple 'pinch points' where meeting another car forces both to stop. Buses and tractors also frequent these roads.

Adding potentially 200-400 cars that use these roads would be dangerous.

In the Main Issues Report it mentions extending Denview Road to the AWPR, this cannot be a serious option. Routing hundreds of cars through this road would be seriously dangerous.

The current residents of Potterton overwhelmingly oppose any attempt to 'develop' the village. The Greenbelt location is what brought most of us here.

Personally I wouldn't want 5 years of my children's lives spent growing up on a building site.

Greenbelt should always remain Greenbelt.
