Reason for change:

Vision for Cuminestown states we have shops and a regular public transport system. We have one small food shop, regular public transport? Someone has got that wrong. What employment opportunities are being created in Cuminestown?

I am completely against this development, along with all residents that live alongside this proposed plan. We all invested our money into houses here, our forever homes to bring up our families, to retire etc, for me it is part of the villiage but offered the private, quiet area I always wanted. Creating 60 homes right on our doorstep is unthinkable and quite frightening.

The road leading into Cuminstown past the Commercial Hotel is very dangerous, putting another main entry into a housing development would be scary the way cars speed there as it is.

At my address I share an access drive with BT, the vans come and go all the time, they often park in the hotel car park (which is for sale). If this plan does go ahead then please mark off the area around the BT building for more access for them as they won't have the pub car park forever.

Some local residents saw plans of what the site could look like, this is not shared with us though, I can't find them, we are concerned that our privacy will be compromised. I bought this house because of complete privacy, having a house looking directly into mine will be a complete compromise. This is causing much anxiety for my family.

There are parks down the hill from the school that appeared on previous paperwork, why has it been decided against, it didn't flood, it wouldn't compromise other residents privacy, we are confused as to why this site has been preferred.
