Proposed Aberdeenshire Local Development Plan 2020 - LDP2021 NN/Site OP2, New Pitsligo

I have always longed for a country location and in 2004 had the opportunity to move to the North East. I have happily lived in New Pitsligo for near on 16 years in which I purchased the property as it was not overlooked by other developments; as I had lived in towns and cities for most of my life.

I am a naturalist and an environmentalist and deeply concerned about the <u>major impact</u> your proposed area for development. From 2004 to 2008, when the village had torrential rain and the ground got soaked; it was a common occurrence the water off the fields flooded numerous properties at the bottom end of the street near the woods. Eventually in 2010 or thereabouts this was resolved when work was carried out, a gully solved the problem.

I feel and believe that this development will have a major impact; <u>endangering wildlife and insect species</u> which I enjoy and encourage into my garden (deers, badgers, foxes, voles, frogs, toads, newts, birds, owls, birds of prey etc etc). I love seeing the calves and cows in the field at the end of my garden.

I truly believe that this proposed development is totally unnecessary as it is green belt land and will affect our carbon footprint - more vehicles, population and air pollutions. The amenities is limited and the bus service is non-existent for people having to travel to their employment (which is virtually non-existent in the surrounding areas; as I am well aware of, I have been there) the village school is nearly at it's full capacity. I am aware that private and council properties in New Pitsligo are lying empty.
