

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

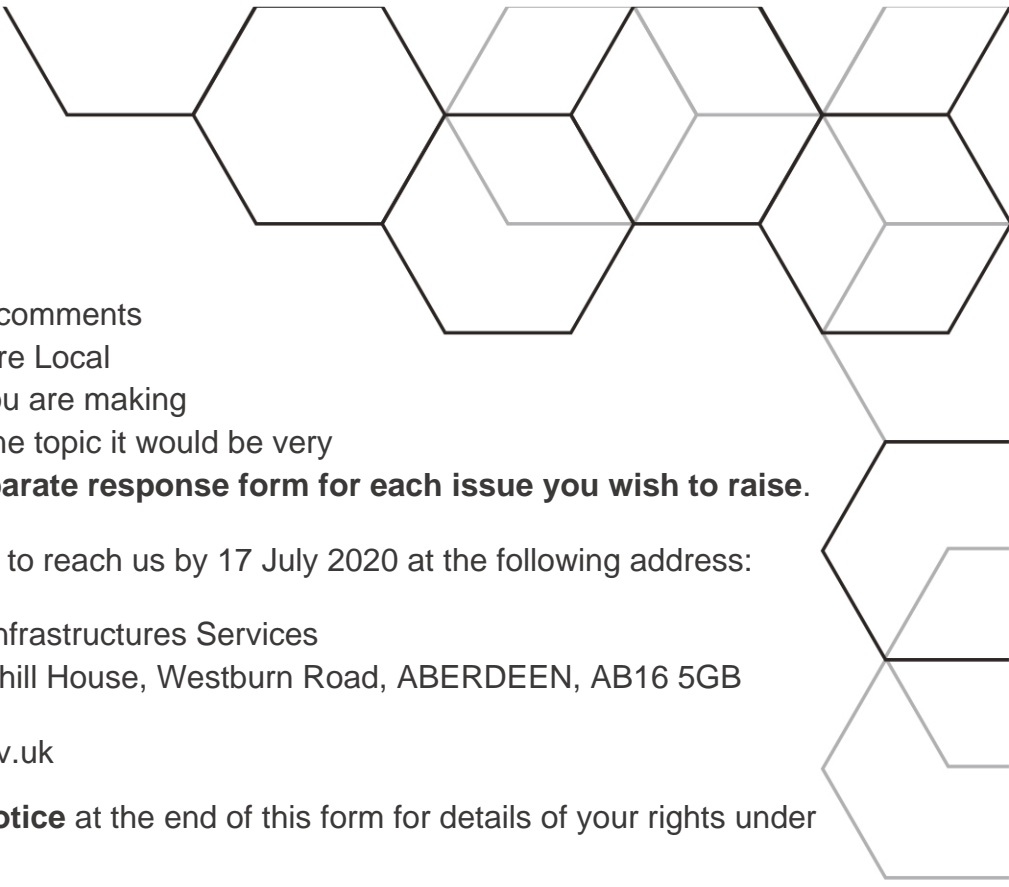

Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

The territory of the resident red kite population should be designated a Special Protection Area in line with EC legislation and International Guidance.

Reason for change:

Red kites are resident in the Drumoak area and are a highly protected species.

They are included in Annex 1 of the EC Birds Directive which states:

Annex I of the Birds Directive lists 193 species and sub-species which are:

- in danger of extinction;
- vulnerable to specific changes in their habitat;
- considered rare because of small populations or restricted local distribution;

Requiring particular attention for reasons of the specific nature of habitat.

For these species Member States must conserve their most suitable territories in number and size as [Special Protection Areas](#).

Red kites are also designated by Scottish Natural Heritage as a Schedule 1A species which states:

The protection afforded to species contained in the Schedules will need to be considered across all aspects of development proposals including planning applications.

The red kite is also on the International Union for Conservation red list as a globally threatened species with a decreasing population.

For these reasons the red kite territory in Drumoak should be designated a Special Protected Area.

The data below is taken from SNH Commissioned Report No.904 showing the population in Aberdeenshire in relation to those elsewhere in Scotland.

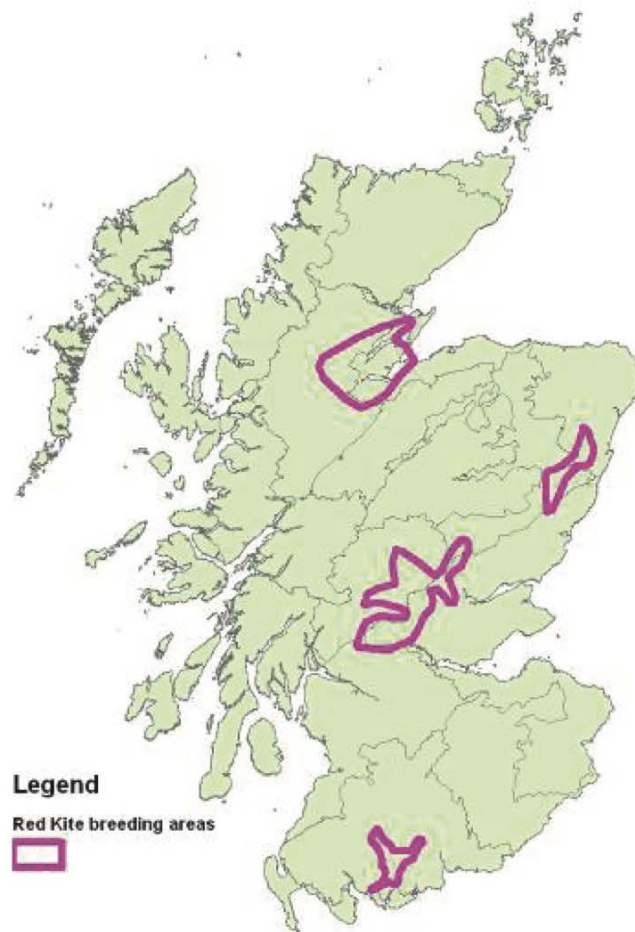
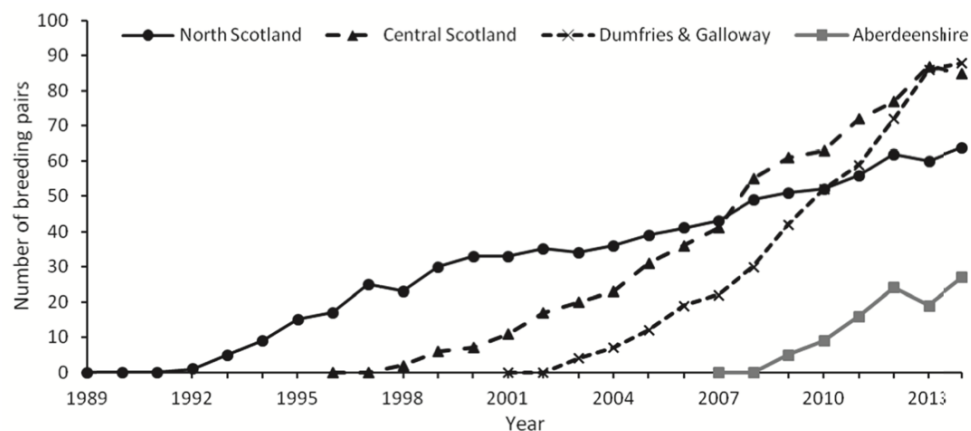


Figure 1. The approximate core breeding areas of the red kite populations in Scotland.

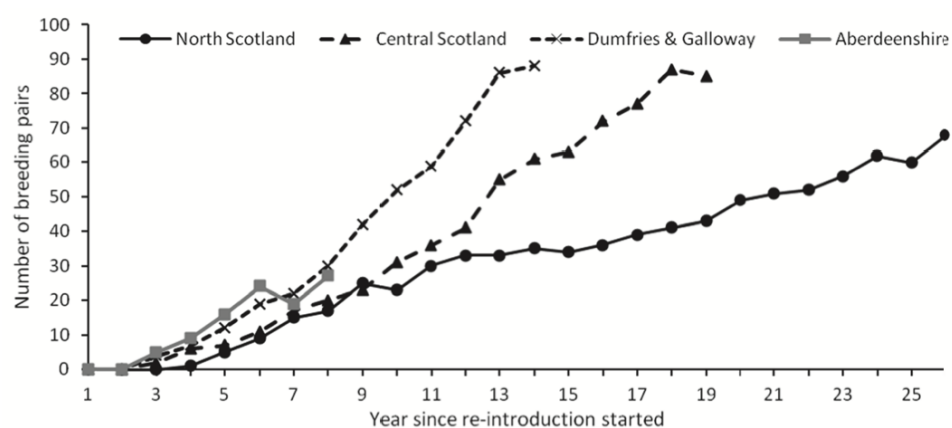


Figure 4. The number of breeding pairs in the four re-introduced red kite populations in Scotland. In a), the number of pairs in each year is shown, whereas in b) the number of pairs in each year since the re-introduction begun for each population is shown.
