

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

CDD CC Drumoak Representatives support Aberdeenshire Council's position of not including a housing development of 600-1500 houses in the area that is currently [REDACTED] Park Quarry.

Reason for change:

It is understood that the developer, [REDACTED], will use the LDP consultation to put forward (again) a proposed development of 600-1500 houses when the quarry is exhausted. The local community overwhelmingly want the area re-instated to agricultural land as stipulated in planning conditions when quarry extensions were granted until 2022. The area is wholly unsuited to a development of this type as there are no amenities nor infrastructure available. There is no bus route in the area, nor capacity in local schools and pupils would have to be transported in buses.
