

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Reason for change:

I object to the development proposal and look for it to be cancelled based on, but not limited to, the following reasons;

1. The already acknowledged incapacity of, WWTW.
2. Already over-subscribed educational provision within the catchment area.
3. Lack of amenities and services within Belhelvie and surrounding areas.
4. Climatic factors due to lack of services in area and resultant need for additional travel by vehicles causing increased traffic and emissions.
5. Lack of any proper infrastructure within the area. While the area does have several access roads, they are not safe and not suitable for the resultant increased traffic load.
6. Dangerous lack of pavements and off-road paths.
7. Poorly maintained public highways not capable of safely supporting additional traffic.
8. Inadequate provision of public transport services resulting in an increase in dependence of the use of personal vehicles negatively impacting the already mentioned infrastructure and traffic concerns, above.
9. Long-term irreversible adverse impact on biodiversity through the loss of habitats and/or habitat fragmentation of species which make use of the area.
10. The existing area proposed for development contains prime agricultural land which is irreplaceable.
11. The landscape experience will be negatively and permanently impacted. Openness, scale, colour, texture, visual diversity, line, pattern, movement, sound, solitude, naturalness, historical and cultural associations will be affected.
