

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Reason for change:

The response that Newmachar Community Council made to the Main Issues Report still stands: The Parish of Newmachar Community Council objects to the current proposals insofar as they do not reflect that Newmachar is an inherently unsustainable location for additional housing, given there is no adequate source of employment within the village and the limited nature of the public transport options available. The travel to work patterns that would necessarily be generated mean that most adults of working age would continue to travel to work by car, aggravating the existing situation. Provision in the plan should accordingly be made to ensure that national policies on sustainability prevail in matters of housing site selection and planning permissions, the amount of land identified for commercial or industrial activities should be substantially increased, and a policy framework identified whereby further housing is postponed until the employment opportunities are significantly increased.

We are pleased to note that, 'in order to meet the community aspiration for greater opportunities for employment within the village, it is considered appropriate to extend the existing OP3 allocation...'
