

RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

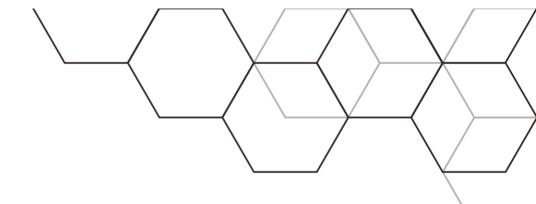
This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



YOUR COMMENTS

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. Once we have done this we will write back to you with Aberdeenshire Council's views on the submissions made. Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Our comments refer to Appendix 7e p688 Kirkton of Maryculter. This section contains the sentence: " there is a desire by the local community for a car park at Kirkton of Maryculter Wood to the south of the properties at Rosebank".

The Maryculter Woodlands Trust, as owner of the Kirkton of Maryculter Community Wood, is happy with the current level of carparking for visitors wishing to access our community wood. We have not picked up any desire from our community members for additional parking so we think this sentence in the LDP can be omitted

Reason for change:

The existing woodland entrance off the public road near where it crosses the Crynoch Burn is sufficiently wide to take about 6 cars without blocking our gate. We do not advertise this area as a carpark but this is how it is used by visitors from the wider communities. Whilst we welcome all visitors to the wood, we still need to manage the access quite carefully as increasing visitor numbers will have an increasingly negative impact on our conservation efforts. The current situation works for us and we think we already have an appropriate level of public access to our community wood.

We think it is also worth mentioning that we have had a LOT of trouble during the Covid lockdown during which we have kept our wood open to the general public. The issues have included fires (despite our signs), unburied human excrement from campers, increased littering and theft of woodland plants (mainly primula & orchids). Clearly we would prefer to put what funds we raise towards improving biodiversity in the wood rather than recovering from thoughtless visitors.
