

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

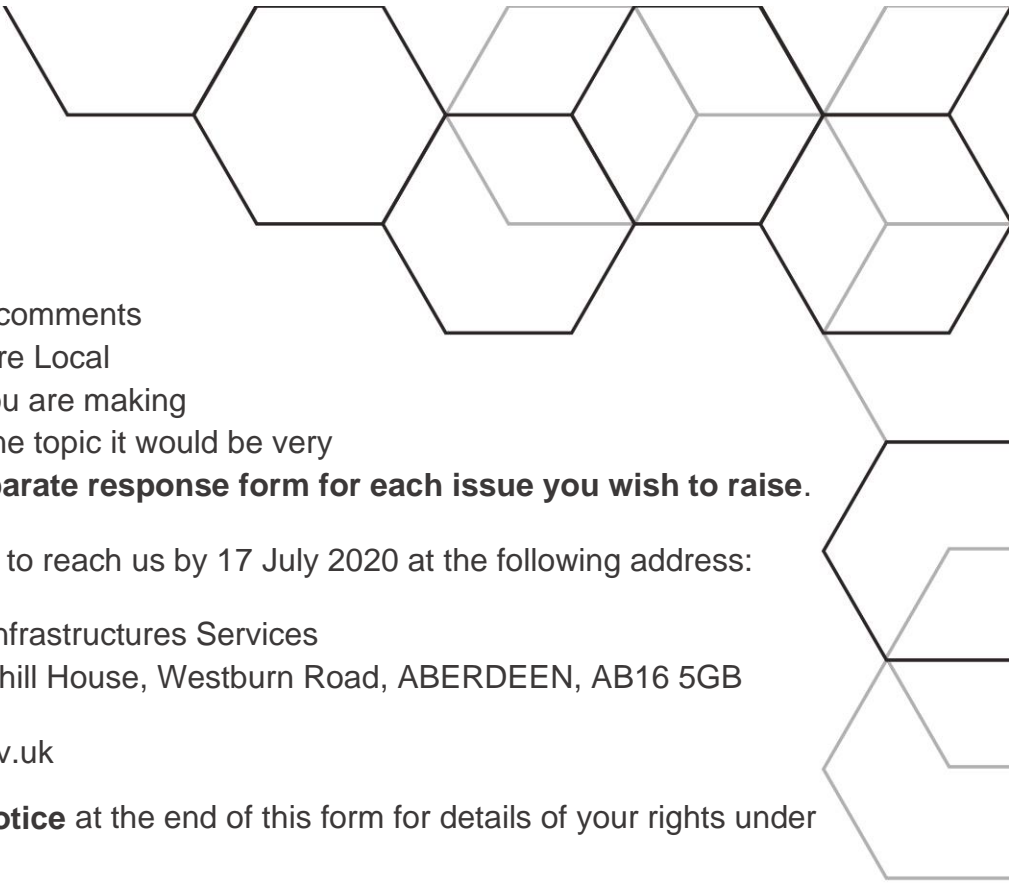

OPI Land south of Earnsheugh Terrace

Reason for change:

I would like to request the removal of the area OPI – land south of Earnsheugh Terrace from the Local Development plan as the land is in an unsuitable location for the building of these homes for the following reasons:-

1 Firstly, the access road is too narrow for the development and does not meet with the rules that exist for adoption as detailed by Aberdeenshire Council in their document 'Standards for road construction consent and adoption'. Detailed table 24.1 requires the road to be a width of 5.5m and pavements of 2m on both sides. The roads are not wide enough to be able for this development. Due to existing houses it would be unable to widen the road and also visibility at the top of the road where extra traffic would be emerging would cause a severe safety issue.

2 Findon has no public transport system and is unlikely to get a service in the future.

3 The village has no footpaths or safe cycle paths to the nearby local amenities at Portlethen the closest village. The road is narrow with only grass verges being an option to use as passing places, there are no pavements for safety and no street lighting.

The above points show that the area of Findon does not meet with Aberdeenshire Council's criteria for an area suitable for development. (Ref. Local Development Plan section 14, RD1.3 and RD1.6)
