

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



OPI Land south of Earnsheugh Terrace

Reason for change:

I wish to request the removal of the area of OPI – Land south of Earnsheugh Terrace from the Local Development plan as the land is in an unsuitable location for the building of the homes as it does not meet with the required standards.

The access road is too narrow and any road constructed could not meet with the rules required as detailed in Aberdeenshire Council 'Standards for road construction consent and adoption' document. It states in 24.1 that the road should be 5.5m wide with a 2m pavement on both sides.

This would increase the village size by almost 20%, there is no public transport to and from the village.

There are no footpaths or cycle ways linking access to local amenities, the roads are narrow with no passing places.

The above issues mean that the area fails to meet with Aberdeenshire Council's requirements for an area suitable for development, I refer to Local Development Plan section 14, RD1.3 and RD1.6)
