

# **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

# This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

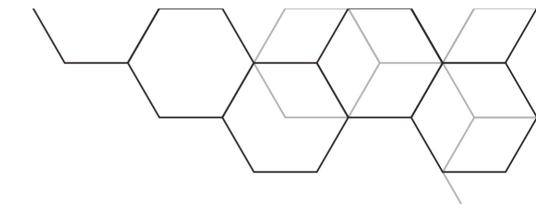
Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



I would like to object to the proposed changes to the LDP for Potterton, Formartine. Proposed development areas OP1 and OP2.

#### Reason for change:

I believe that the proposed changes are an inappropriate use of Greenbelt.

The area around Potterton is currently allocated as greenbelt and a change to develop the proposed areas as housing is not an acceptable loss of greenbelt. It will significantly change the character of the village will not encourage the feeling of community. If this proposed development proceeds it will set a precedent for development on the greenbelt areas and open the door for further development proposals to be put forward, expanding the village significantly.

I do not believe that a development of this size is of suitable scale or form for the character and look of the village.
