

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

# YOUR COMMENTS

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. **Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

I would like to object to the proposed changes to the LDP for Potterton, Formartine. Proposed development areas OP1 and OP2.

## Reason for change:

I have serious concerns about the unsuitability of the roads servicing this proposed development and the significant increase in traffic during the construction phase and afterwards.

The proposed developments at OP1 and OP2 have vehicle access onto an unclassified road that leads from Potterton to Milton of Potterton and then from Milton of Potterton to the new Blackdog roundabout. Both during the construction phase and afterwards these roads are not suitable for the increased traffic. The roads have narrow pinch points between houses where it is not possible to have 2 large vehicles passing without significant difficulty, there are blind bends and crests where visibility is significantly limited. High bank verges on some of the narrow corners make it very difficult to pass without further degrading the banks.

The junction between the Potterton to Milton of Potterton Road and the unclassified road leading to the Blackdog roundabout is at an acute angle which is impossible for large vehicles to negotiate without going onto the other side of the road. The view from the Belhelvie side is also obstructed by a hedge so increasing the risk of accidents. I regularly drive a 12 ton HGV horsebox along this road from the AWPR to the village and have first-hand experience of the difficulties myself. If vehicles are coming the other way, you have to plan your approach to the narrowed areas so you are not meeting other vehicles at the narrowest parts.

The lower road that leads to the Blackdog roundabout is also susceptible to significant surface water draining from the fields above, and freezes badly during the winter due to the high ground on either side sheltering it from any sun. This will result in an increase to the risk of accidents.

I have lived in the village for 40 years and have ridden my horses on the surrounding roads all that time. Over the years this has become increasingly dangerous with the volume of traffic. The roads surrounding this area are often narrow, with unsighted corners and poor visibility at junctions. During the 4 – 5 years of construction of the AWPR and increased HGV traffic on those roads I found the roads completely unsafe to

ride on due to the volume and speed of the traffic using these narrow roads. This will only be repeated if there is a development of this size in the village.
