

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Objection to LDP Settlement Plan for Echt OP1

OP1: ECHT, NORTH OF FORBES PARK

Flood Risk

- The OP1 area of the Echt current plan is adjacent to an area (P2) that is vulnerable to flooding. This is a separate risk in addition to the P2 area that has been identified as a flood risk area and excluded from the development plan

Reason for change:

The Echt OP1 area is at risk of the flooding spreading from P2 with moderate to heavy rain.

The photos attached (x2) show examples of the flooding in October 2019 and March 2018 (widely viewed on Facebook). I have further flooding photos from previous years (every 6 to 12 months).

The flooded area is well documented by many on local social media and has been included by SEPA (attached SEPA flood map 18072020) in their flood risk area maps.

Existing newly built properties in the previous development adjacent to OP1 have already been officially reported (and reported in social media) flooding in their boundaries during previous years.

I believe under the Local Development Plan 2021 Site Ref GR092 Land North of Forbes Park Echt would be enveloped by the regular (every 6 to 12 months) floods similar to those as seen in these photos.
