

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

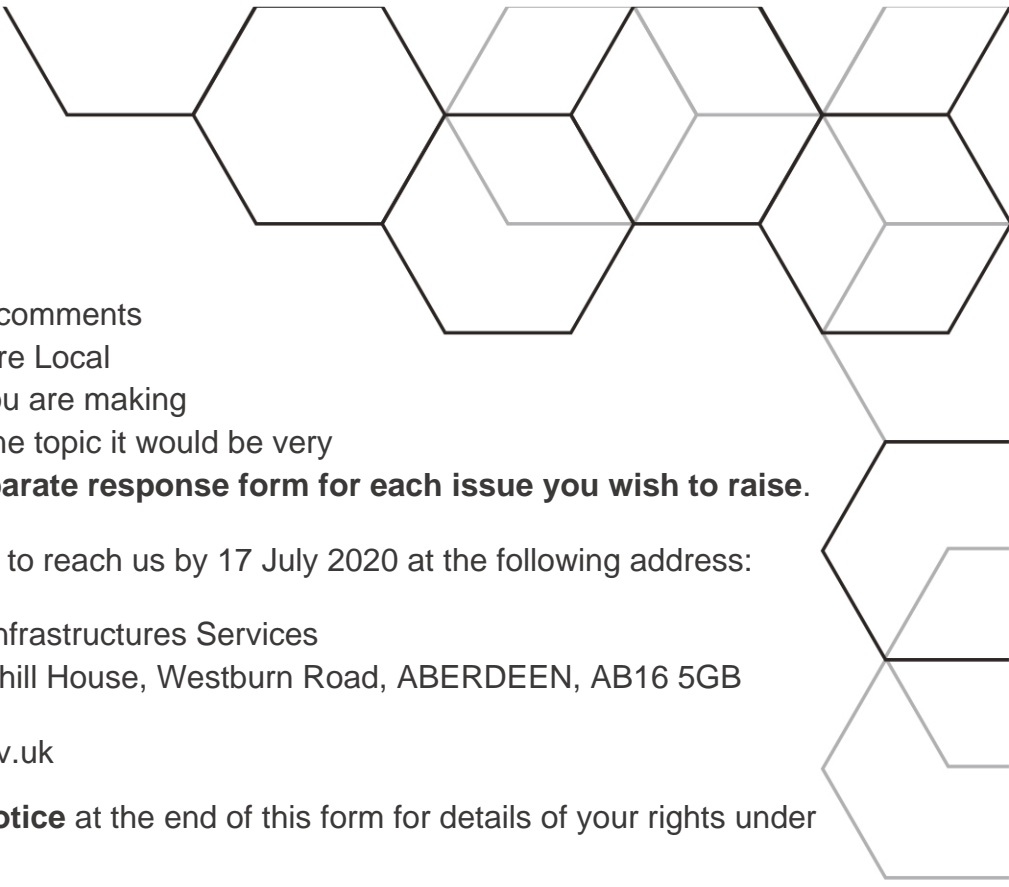

As a person who has spent many years in Methlick I am not happy about what has happened within the last few years, meaning the loss of our surgery the closing of our two banks, and we are now in the close down of our local garage, also in the past we have also lost, the Higher Grade section of Methlick school, which taught French and Latin, I question why should Methlick have those losses be given to other villages!

Now the question of building new Houses, number one because of our losses I want to see more built to give us back our share of progress, taken away from us by invisible people. I would like to see houses built in a controlled manner, giving the four applicants the chance to build. I think at present the difference between the children from the old farming way, and the children from the Council, that are those who go to school just now would not be far from level.
