

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



## Reason for change:

The Crathes Drumoak and Durris Community Council, representing the Durris community, wish to voice their support for the decision to exclude from the LDP, the development- Kincluny Village- submitted by [REDACTED] in Durris, on the site of the Park Quarry, with a proposal for between 600 - 1500 houses.

The planning permission granted by Aberdeenshire Council to [REDACTED] at the start of quarrying states specifically that on completion of quarrying and/or the quarry being exhausted, the site will be reinstated to agricultural land. The community council understand that this planning permission is still in force.

The community council note the following specific policies in the 2020 LDP, policies R1 Special Rural Areas, and R2 Development Proposals Elsewhere in the Countryside:

### ***'meets local needs'***

There is no need for additional housing on this scale in Durris or Drumoak

### ***'only permitted in exceptional circumstances'***

There are no exceptional circumstances

### ***'demonstrated beyond reasonable doubt that (a development) will not cause adverse social or environmental impacts including sub-urbanisation of the countryside.'***

The impact on local infrastructure which is already inadequate, social interaction, and the environment, is unthinkable.
