

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

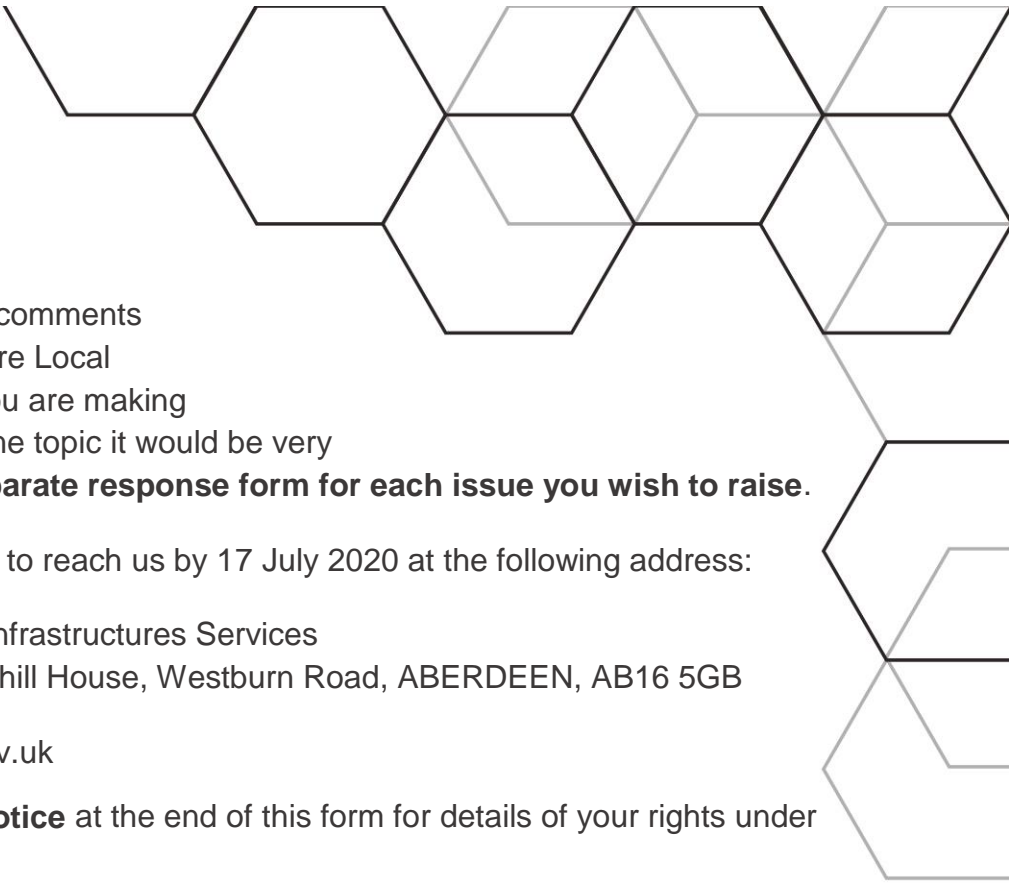

Reason for change:

The Crathes Drumoak and Durriss Community Council (CC) fully support the stated aims of the Settlement Features P1 and P2, and that there is no requirement for further development at this stage.

Speed Limit on B9077

The CC note the current proposed development at Easter Durriss to the east of the village with both houses fronting the B9077. The CC has long campaigned with residents to reduce the current speed limit through the village. It is hoped that in the event of these additional two houses being built, this will trigger a review process of the current speed limit, with the aim of reducing the 50mph limit.

Recycling and Waste

The CC are liaising with Aberdeenshire Council and residents on the siting of a glass recycling facility adjacent to the Kirkton of Durriss Hall. This facility will be of use to all Durriss residents in addition to aiding strategic recycling and waste infrastructure, particularly with the closure of Park Bridge.
