

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

APPENDIX 7C SETTLEMENT STATEMENTS FORMARTINE - Methlick

Reason for change:

As chairperson of the Methlick Community Council (MCC) I have to some extent already expressed my concerns over the proposed development plans, but though we have submitted our feelings as a collective, I have encouraged members of the community council to feedback their own thoughts to the Council regarding the plans and these are mine.

It is disappointing that following the meeting with the Council back in 2017 that the wishes of the community council appear to have been ignored. A number of the land owners of the plots are themselves surprised at the number of properties now being considered for their different plots.

This in itself has caused suspicion within the community:

- Are the council looking at proposing a high number of builds, so that, following a review, if the numbers appear to be cut they are in reality still above the original plan?
- Will the high numbers in the plan mean no developments proceed?

As a community we have recently lost the satellite Haddo Practice GP surgery. Something the Community Council foresaw when, against strong opposition from the community, the dispensing service was taken from the practice.

Now, once more suspicions are rife within the community that there is something else on the agenda with regards to Methlick.

Personally some considered and appropriate development within the village would not be an issue. To potentially build in excess of 100 homes in the next 10 years is not acceptable.

The impact these new homes would have in the village would be considerable. The increase in traffic flow and volume through the village, plus the impact on the Category B

listed bridge crossing the Ythan river.

The extreme number of homes will also have a detrimental effect on both the pupil role and the classroom sizes at Methlick Primary School. The report highlights that with regards to Secondary education all developments will be required to contribute to the provision of additional capacity at Meldrum Academy, however there is no mention of any provision for the Primary School in Methlick. This to me seems wrong the village where the homes are being built and where the most impact will be felt, should be in receipt of any 'compensation' and developer funding.

So, as you can probably tell, there is little support from me, nor, from conversations I have had in my position as Chairperson of the Community Council, the wider Methlick community with regards to the current LDP 2020.

As was stated in the Methlick Community Council response I hope, given that this is a consultation period and this is a 'proposed local development plan', that there will be further conversation and consultation with the Methlick community and the concerns of the Methlick community will be heard and changes to the development plan made.
