Reason for change:

The access proposed is used by a bus company. It is a four-way junction at the square which has two blind bends. The increase of vehicles makes this a dangerous place for walkers and traffic. The proposed access road joins a public pathway and right of way. This is well used by villagers walking their dogs and for general exercise. This again would be more hazardous for villagers and a loss of amenity. The village has very little amenities as it is.

My neighbour has also created a small nature area in the adjoining field. Extra traffic would spoil this area.

Our village has had problems with its drainage because of lorries using it as a shortcut. The drains are crumbling, extra houses would exacerbate this.

I realise extra housing is needed but New Byth has no amenities to support them. The proposed access would spoil our one area that the villagers use. Moving it to the end of Urquhart Road would be a lot better.


