

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Increase in the number of units identified for site OP2 Newmachar from 95 to 115.

Reason for change:

Strategic Land (Scotland) Ltd formally object to the proposed ALDP 2021 in respect of the housing capacity of Site OP2. In particular, this objection relates to the incorrect identification of OP as having a remaining balance of 95 units when, arithmetically, it should be 115.

This objection is submitted without prejudice to submissions also made by Strategic Land (Scotland) Limited in respect of allocation unit numbers as informed by the Council's standard density base and within the wider objections submitted by Homes for Scotland in respect of the under provision of housing land within the proposed ALDP.

Following the publication of the proposed draft plan alongside the MIR, the subject lands, identified as OP2, were adjusted by officers prior to presentation to and approval of the proposed plan at the Aberdeenshire Council's Committee on 5th March. Essentially, in this, the developed part of OP2 has now been removed and the overall unit numbers has been reduced from 185 (as identified by officers in the draft proposed plan issued with the MIR) to 95.

Within the draft proposed plan, Site OP2 included 50 of the 70 units built out by [REDACTED] here. The remaining 20 units were outwith OP2; on white land to the south east of OP2. So, with an accepted 165 unit capacity identified within the draft proposed plan for OP2, the removal of the built out part of OP2 would mean the balance of the site being reduced by 50 units meaning the site capacity reducing from 165 to 115 units.

The basis for a 90 unit reduction is not understood. It is submitted that this error should be corrected and the site capacity be confirmed as 115 units.
