

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

FR098- Land north of ST KAtehrines, Fyvie.

I agree with the statement proposing 35 houses.

Reason for change:

I am commenting as the landowner of the area FR098 contained within the LDP 2020.

We are in the process of getting the S75 signed with the legal department of Aberdeenshire Council. This will enable us to begin the development of the 15 houses which have been consented already at St Katherines. We have a builder on board, [REDACTED], to begin with this development. There has been interest for housing locally and we propose to begin this development imminently.

There are high infrastructure costs associated with the 15 houses and so phase 2 of the development, which are the 35 houses, will help spread these costs and make the site profitable.

The local school at Fyvie has a declining role and so this will help to increase that . This will make it easier to ensure there are enough teachers at the school to continue with the standards of education at Fyvie.

The local residents are concerned with access onto the A947 and the proposed new junction will have the safety features of a reduced speed limit on the road and also better visibility. This is something which the local residents would be pleased to see.

The employment land will also be in demand locally and we have already been approached by a local business for an office and small business unit. The local units will help to have residents work and stay locally.

As I have mentioned, as the landowner we are committed to this development and we see the benefits it gives to the local area. Hopefully we can get this included in the new LDP.
