

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. Once we have done this we will write back to you with Aberdeenshire Council's views on the submissions made. Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

I refer to Aberdeen City Council's LDP - specifically their inclusion of 'Royal Devenick Park' (OP46, bid 1308 'Leggart Brae') as a 'housing opportunity'. Part of this proposed site lies in the Shire's authority and is green belt land. I can find no mention of this site anywhere in the Shire's LDP. This site information should be included so that the public can comment.

Reason for change:

The Aberdeenshire LDP quite rightly shows no housing allocation for the Leggart Brae/Banchory Devenick area. However, the proposed Leggart Brae development, although largely within the City, is seen by the developer as the first phase of a much larger development that would be mainly within the Shire. As such it may well be the subject of a Development Bid for later inclusion in the LDP. If any "new sites can be added into the Proposed LDP after this consultation", please make sure that there is full public consultation on any new/revised bids which would be a material addition to the LDP.

Housing development in the Leggart Brae area is not acceptable for a number of reasons:

- It encroaches on designated Green Belt land (App 4 Map 8) and conflicts with the Shire LDP policies on Natural Heritage and Landscape
- It increases the over-supply of housing in the Greater Aberdeen area. Current developments are proceeding slowly due to lack of demand, leading to prolonged disruption during construction and an increasing number of properties on the second hand market. The coronavirus depression and the further recent decline in the oil and gas market will only enhance this situation.
- The Leggart Brae area is very poorly served by active travel infrastructure and public transport.
- Plans for access to the site, both during construction and after development are not compatible with the nature of local roads, particularly Causeymouth Road and South Deeside Road.

In conclusion, I fully support the Council's fortitude in upholding important policies in order to keep the special status of Banchory Devenick, Aberdeenshire. I sincerely hope this fortitude holds up in the future so that your aim stated in your LDP 4.8 "the right development in the right place" continues to be realised.
