

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020

RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Area Marr, Banchory Settlement, OP6 Land at Former Glen O'Dee Hospital.

Reason for change:

It is noted that the settlement boundary has been extended to include what is now described as an allocated site. It is disappointing that the narrative does not make reference to this boundary extension.

There is a discrepancy on the position of the settlement boundary on the south-east of the site, between the MIR and Draft Proposed LDP 2019 and as now shown in the Draft LDP 2020. This area of [REDACTED] land is out-with the proposed allocated site and should be shown as out-with the settlement boundary so as to avoid any future applications.

It is welcomed that the Development Bid has been reduced from 100 homes to 40 homes, although the latter number is still in excess of the 29 homes which was approved for the site in the last successful planning application. There needs to be certainty that the numbers are not indicative but, are a maximum number given, the planning applications which have been submitted previously.

Corsee Road from the entrance to Roscobie Park to the hospital is a private road. The narrative for OP6 indicates that access to the site will be from Corsee Road however, this needs to be determined through the planning process to determine if Corsee Road is the most suitable access given the current volume of traffic to the existing hospital and the lack of Public Transport. Access to the Development needs to take account of Policies RD1.3 to RD1.8 and a Transport Assessment rather than a Transport Statement should be required. Reference to Corsee Road should be removed from the narrative and substituted by a suitable access to this allocated site requires to be determined.

Previous planning applications by the developer have suggested that any Woodland loss could be mitigated by compensatory planting on a site outside the Banchory area. Woodland loss should be offset in accordance with Policy PR1.8 and this needs to be clarified in the narrative to this allocation.

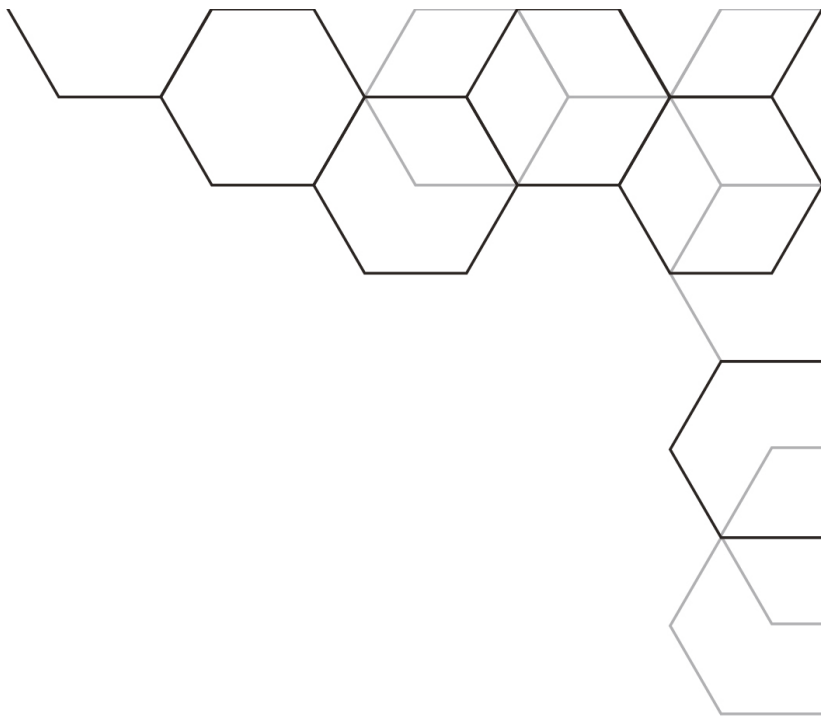
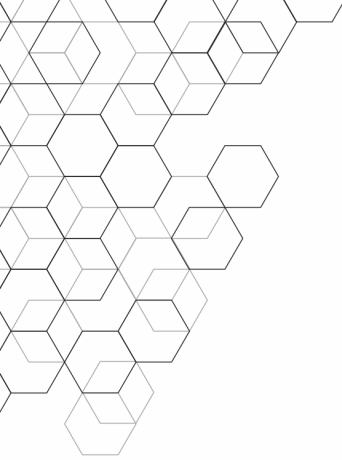
