PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 **RESPONSE FORM**

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

The green area proposed by the builder.

Reason for change:

The builder proposed to plant trees in the lower part of the development. However, as I am sure you've seen from the photos of other people who submitted comments (I don't have photos myself), the area is prone to flooding and if there is no visible water, the area is often boggy. Many trees that were planted on the Phase 2 development close to the site have died as soon as they were planted (they are still standing dead on the site). I am afraid the same thing can happen in the phase 3 and we will have a dead forest there.

I think this area has to be developed differently. Playground would be a good option with good ground covering that resist flooding. There are a lot of children in the phase1 and 2 houses and I am sure there will be more with phase 3.

If trees are to be planted there should be proper drainage in place. And dead trees should be replaces in the timely manner. On the phase 2 trees we were promised that trees will be replaced but nothing happened until they were out of warranty, even with many reminders.
