

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

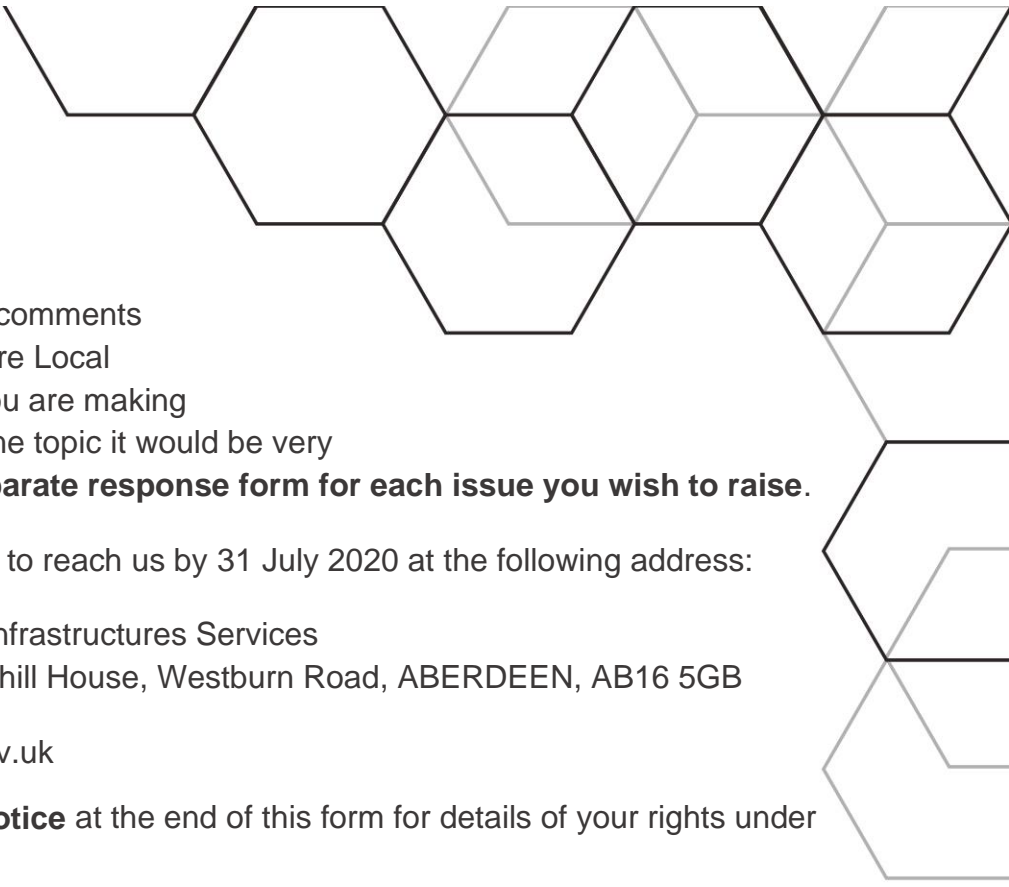

# YOUR COMMENTS

**Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Policy R2 Part 16 – Extensions to Clusters/Housing Groups

The boundary between the Remote Rural Area and Accessible Rural Area should be revised to the current LDP boundary line, or alternatively a separate clause allowing more restricted extensions to clusters within the Accessible Rural Area ie. a maximum of 1 additional house per plan period to clusters of 5-10 houses or similar.

**Reason for change:**

The change of boundaries from the current LDP will greatly reduce the availability of single Self-Build developments within Aberdeenshire.

There appears to have been no consideration or analysis of how many houses which were approved under this policy within the current LDP and how this will impact on the deliverability of Aberdeenshire's housing needs during a national wide housing crisis.

Given that the government is actively encouraging Self-Build homes and trying to promote its use in order to improve the delivery of the new housing needs, it seems very odd that Aberdeenshire Council would seek to restrict Self-Build homes in such a way.

It should also be considered that generally speaking Self Build homes are built to much higher standards in terms of Energy Efficiency and Sustainability than large scale developments are, as the Self Build is built by the end home user who is looking at the bigger picture in terms of running costs and future carbon footprint compared to larger developers who are looking to simply sell on finished products for profit.

It should also be noted that many of the sites allocated for housing within the proposed LDP have been contained within the previous LDP's going back at least 8 years, with little or no advancement on delivery of these developments during this time. This further enhances our belief that the availability of small Self Build sites needs to be improved rather than reduced in order to provide easily developable sites that can meet the housing needs while larger sites are not developed.
