

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Modification that you wish to see (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

Policy H2 – Affordable Housing

Additional clause should be added in relation to provision of affordable housing to large brownfield sites of up to 7 houses as would be allowed under Policy R2 for development in the countryside. This clause should indicate that affordable housing will not be required to be provided, but instead a commuted sum may be required to be secured under Developer Obligations to go towards Affordable housing within a nearby settlement/s.

Guidance on how this commuted sum would be calculated would also be welcome although it is recognised this would likely form part of Policy RD2 – Developer Obligations.

Reason for change:

Due to the nature of brownfield sites within the countryside out with settlements, they are not generally suited to affordable housing as these sites are set in remote rural areas with very limited access to public transport and nearby essential facilities.

It would be unlikely that many people would meet the criteria to be eligible for affordable housing, but would also be able to afford the costs associated with a new house as well as the necessary costs associated with owning and running a vehicle constantly to access shops etc.

Whilst it is understood that agreement could be made with Developer Obligations on a case by case basis, but it would provide greater certainty and assurance to potential developments that they would not be limited by the possibility of having to provide an affordable unit which would be unlikely to be sold/taken up.
