

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



# YOUR COMMENTS

Blackdog Settlement Boundary / Greenbelt Boundary

Blackdog settlement boundary should be amended to include the land marked on the attached site plan drawing.

The greenbelt boundary should accordingly be amended to exclude the area of land marked on the attached site plan drawing.

**Reason for change:**

As can be seen in the attached site plan there is an existing shed which was completed in accordance with planning approval APP/2016/1272 and is accessed from Hareburn Terrace so should be included as part of Blackdog given that all other buildings in the area are included within the boundary. This shed does not seem to be represented in the updated map of Blackdog but does exist on site so the map/boundary should be amended accordingly.

Additionally as this area of land has now been developed on with associated storage area around the building, the land should no longer be classed as Greenbelt land. It was also noted within the planners report of handling of application reference APP/2016/1272 that - "The area of greenbelt the site occupies appears to be of little value. The site is too small and isolated to be indicative of a separation between the town of Blackdog and the countryside, with the surrounding roads and burn identifying a more obvious boundary. It is of insufficient size to be used for most agricultural purposes, and it is not identified as being of particular value as a habitat for wildlife. On the basis of these matters, it is considered that this site is an exception to other areas of greenbelt, and the proposal is considered uniquely on its own merits as a result of this."

A submission was made by [REDACTED] on my behalf in relation to Issue 66 Blackdog and was formally acknowledged as MIR Ref 28, however based on the Issues & Actions Paper for Formartine Area it does not appear that there has been any consideration or assessment of this submission.
