

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



# YOUR COMMENTS

Please provide us with your comments below. We will summarise comments and in our analysis will consider every point that is made. Once we have done this we will write back to you with Aberdeenshire Council's views on the submissions made. **Modification that you wish to see** (please make specific reference to the section of the Proposed Plan you wish to see modified if possible, for example Section 9, paragraph E1.1):

I oppose development at Aberdeen site OP46 (B13/08), which extends into Aberdeenshire and requires road access from Aberdeenshire (the site adjacent to Deeside Brae and named Royal Devenick Park by the developers).

I continue to oppose development at Aberdeenshire sites KN069-072 in Banchory Devenick (B1308).

## Reason for change:

Further to my response (ANON-B3JU-DSG5-7) in May 2019 where I agreed with the authors of the 2019 draft of the Main Issues Report that sites KN069-072 were undesirable, it is my understanding that there has been a revised proposal for a smaller area that spans the Aberdeen and Aberdeenshire boundary.

I request that Aberdeenshire council reject the part of the proposed development that extends into Aberdeenshire and rejects any road access via Aberdeenshire.

### 1. Causey Mounth Road

The Causey Mounth Road is our main access into and out of the Banchory Devenick area. Any interruption of access would be highly problematic.

I understand that the proposed development is dependent on road access to the Causey Mounth Road. The development would considerably increase traffic between the access point and the South Deeside road. That stretch of the Causey Mount includes a blind bend and the steepest section of road. I believe that the addition of vehicular access for 150 houses would significantly increase the risk of accidents on the Causey Mounth.

### 2. Green Belt

The development is in the Aberdeen green belt. Any development would affect the nature of the views into and from Aberdeen and set a precedent for further erosion of the green belt.

### 3. Implications for Banchory Devenick

Although the proposal is small relative to that originally made by [REDACTED] it would set a precedent. If any development is allowed it may be more difficult to say no to more. From their original request for sites KN069-072 it is clear that the developers intend further development. Indeed, it is my understanding that [REDACTED] bought the entire

Banchory-Leggart estate a few years ago which means that it is only planning restrictions that prevent them extending Aberdeen south to the AWPR and west to Banchory Devenick Church.
