

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Appendix 6 Housing Land Allocations, Table 2, Portlethen OP1. I would like to see a reduction in allowances for 2020-2032 from 176 to 60.

Appendix 7e Settlement Statements – Kincardine and Mearns, Portlethen, Allocated Sites, OP1. I would like to see allocation reduced from 176 to 60 homes.

Appendix 7e Settlement Statement – Kincardine and Mearns, Portlethen, Settlement Features. I would like to see the equivalent of 116 homes worth of land added to the Protected Areas listing to “protect the area of open space as an amenity for the settlement and forming part of the green-blue network.”

Reason for change:

The open spaces strategy audit of Portlethen in 2008 (<https://www.aberdeenshire.gov.uk/media/6176/portlethen.pdf>) highlighted that “the significant areas of amenity greenspace are not, on the whole, accessible as usable amenity space to the community, being largely a combination of transport amenity along the A90 [now A92] and business amenity within Badentoy Industrial Estate.” It goes on to state “additional opportunities for safe access to semi-natural greenspace at the north end of the village would be of benefit.” I was encouraged to see a public park proposed for the OP1 area in the Local Development Plan Main Issues Report published in 2019 and am disappointed to see this didn't make it into the proposed plan as available today.

As of July 2020 there is still insufficient safe, semi-natural greenspace for the part of the Portlethen community which is located west of the A92, limiting the possibilities for building a cohesive community and encouraging exercise/healthy lifestyles. This has been very noticeable during the Covid-19 lockdown. Public comments on planning applications continue to highlight this as a major community concern, and although an adventure playpark has been added to the pending planning application following public pressure, this is still far away from providing the needed usable greenspace in the area.

Given this lack of usable greenspace, a part re-allocation of the proposed OP1 area at Schoolhill to become a public park would be of significant benefit to the community, creating opportunities for healthy lifestyles and wellbeing through easier and safer access to exercise, and promoting community identity and cohesion by providing safe and easy access to usable greenspace within the area. The greenspace would also be of significant benefit to the primary school, nursery and organisations working with young people in this part of Portlethen.
