

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Proposed Plan Appendix 7F: Settlement Statements Marr (page 782) – proposed P16 protected land designation should be removed

**Reason for change:**

The above mentioned site has planning permission in principle for 5 houses. There is a significant history associated with this site, Planning Permission in Principle was granted in June 2014 through Aberdeenshire Council application reference APP/2006/4043 and more recently in 2017 we applied to renew the Planning Permission in Principle (application ref. APP/2017/1919) which was subsequently approved in May 2018. Difficult market conditions within the North East as a result of the downturn in the Oil and Gas industry through a fall in the oil price in recent times has had a significant knock on impact to the house building industry but we fully intend proceeding and completing development on this site with a Matters Specified in Condition (MSC) application in progress at the moment (Aberdeenshire Council application reference APP/2020/1399) which details the site layout, house types etc. An Ecology Report was submitted during the renewal application, the report concluded that there were no signs of protected species or vegetation of any value and therefore in accordance with policy as there would be no harm to protected species. As part of the MSC application we have undertaken a tree survey with the majority of established trees surrounding the boundaries of the site retained which will allow the development to retain a woodland setting. The 5 plots on the site will all have substantial feus and garden ground, a landscaping scheme has also been submitted which allows for additional trees, shrubs, hedges, grassed areas and greenspaces to be included. Footpaths linking Raemoir Heights through the site to the existing footpaths located towards the west have been included within the site layout to aid with connectivity.

The site is an appropriate infill development site, it would have little negative impact on the surrounding area and the Planning Service is content that the site can accommodate the development proposed, the site complies with the relevant policies and in particular, Policy P3 of the Aberdeenshire LDP 2017.

In view of the above, we hereby request that the proposed plan is amended in line with the modification detailed at the outset of this representation
