

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



*The village has a Conservation Area where the square and historic 12<sup>th</sup> century church form the central area.*

**Reason for change:**

**There needs to be more detailed recorded awareness of the historic Scottish significance of Monymusk as a Historic Environment.**

Monymusk Church is certainly 12<sup>th</sup> Century and the tower maybe earlier. It is highly significant in that it is probably the oldest church in Aberdeenshire still in use and is associated with the adjacent archaeological site of the Monymusk Priory which is partially enclosed by but NOT mentioned by P4 and P5. Recent discoveries elsewhere in Aberdeenshire i.e. Rhynie, suggest the Early Mediaeval Period has been ignored and is in danger of being overwhelmed and lost through modern development.

Our concern is that this maybe lost because it is not recorded in the introduction which should give a more complete a sense of place and significance.

That this is not mentioned continues to ignore what is potentially an important historic church linked to an early monastic religious site with 6<sup>th</sup> and 7<sup>th</sup> century gravestones and later Pictish Class II symbol stone.

This lack of awareness has led to destruction of archaeological Priory evidence by the Council's own employees in that two stones unearthed during the excavation of a lair/grave were discarded as waste/rubbish during the Minister's holiday absence.

(The entry in Section 11 indicates a reassessment is required for Monymusk Conservation area as the entry contains virtually no information or plan.

The **conservation area** is a planned 18<sup>th</sup> century village; with further unique 19<sup>th</sup> century architectural enhancement which give a strong sense of place; and site of the 18<sup>th</sup> century Scottish Agricultural revolution.

This sense of place has been diluted by modern residential housing that is typical of any modern residential development rather than reinforcing identity.)

The village should have better recognition of its Historic Environment significance, particularly in respect of conservation and tourism potential and yet Monymusk church does not even feature in Aberdeenshire Council's own list of important churches or archaeological sites.
