

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Flood Risk

The Todlachie Burn runs through the village and past the sewage works to an outfall at the River Don. There have been incidences of flooding and damage to riparian properties in the village, closure of road access to the village and overwhelming of the sewage works. A Flood Risk Assessment may be required.

Reason for change:

The most recent housing development in Monymusk was in constructed with a subterranean SUDs scheme which contributes surface water drainage to both the sewer system and the drainage network rather than a collection pond. The surface drainage joins the Todlachie burn at the bridge contributing and potentially backing water up at the bridge in the village.

The community council (Cluny, Midmar and Monymusk community council, CMMcc) also understands there is still an ongoing investigation by Planning Enforcement. This is into alleged drainage connection breaches which residents allege contributes excess surface water into the Todlachie burn above the village rather than below. So causing further flooding, overwhelming of the sewage works and pollution of the River Don. Flooding by the Todlachie burn caused significant financial damage to the riparian properties in the village.

This allegation and investigation commenced after the CMMcc had initially responded to the LDP consultation.

Whatever the results of the investigation, it should be recorded that there is a Flood Risk in regard to the Todlachie Burn and any further developments (currently reserved) should take this into account and a Flood Risk Assessment be required as acknowledged in the associated SEA.

There have also been incidences of the road at the Todlachie bridge being overwhelmed by flood water during extreme summer cloudbursts in the catchment. Emergency access for some village residents in such circumstances would require a 10km diversion via Todlachie and Pitmunie or 16km via Kemnay and Blairdaff assuming that route is accessible over the Ton burn on the B993,
