



PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a ‘Main Issues Report’ was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan (“the Proposed Plan”).

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

The published Main Issues Report identified site MIR019 as an “Officer’s Preference” site for longer term development for c. 84 housing units beyond the 10 year period of the next Local Development Plan 2021-2031. An indicative phasing plan of the housing site was also presented at the Aboyne drop-in event (27th Feb 2019), which included green space and road layout.

The proposed settlement plan in the draft LDP has seen the removal of this reference to the potential for future long term development, and instead surmises “reasonable housing allocations”. We would like to appeal the change in Officers’ position here, and ask to have the longer term “Officer’s Preference” for housing in this area reinstated for the period beyond the proposed 2021-2031 LDP. The current proposed plan identifies one site for housing, (OP3, 8 homes, LDP 2017) and does not give reference to any longer term look ahead. We would like to place a marker in the plan now for future housing development, as it was identified in the MIR.
