

## RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

# This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

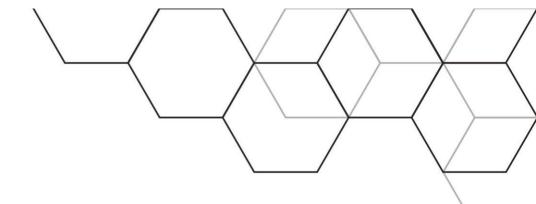
Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



## Section 6, **Policy B2 Employment/Business Land** Paragraph 2.2

Suggest the Council considers providing further guidance on the evidence landowners will be required to present to demonstrate the constraint and the degree to which it precludes employment generating uses on the site. An approach similar to the one taken in Policy B3.2 involving a professionally qualified person, such as a land surveyor, would be useful to demonstrate the lack of take up is as a result of the constraint. Assessment could include whether the land in question has been marketed for an extended duration of time at a reasonable market value.

#### Reason for change:

It is noted that the policy includes provisions to protect the local community and ensure the alternative use is compatible with adjoining uses which is clearly welcome. The suggested change would set out what is required of landowners seeking to secure alternative uses on these sites and would to a degree provide some protection to the more marginal, but possibly still viable, BUS designated sites.
