## PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020

### RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

Whilst there are three recommended changes below, they all relate to the single issue of an appropriate and suitable policy context and representation regarding the Acorn Carbon Capture and Storage (CCS) & hydrogen projects within the Aberdeenshire LDP.

#### **Recommended Change 1**

Policy PR2 Reserving and Protecting Important Development Sites PR2.2 – Amend text to:

National Developments that directly affect the area covered by this plan include proposals for the contribution to capturing and storing carbon, the production of hydrogen from natural gas as a low carbon fuel and making heat generation. Carbon capture and hydrogen production is specifically promoted at the St Fergus gas terminal but also at other locations and pipeline corridors associated with the movement of CO<sub>2</sub> by ship via Peterhead Port and pipelines from central belt to St Fergus.

#### **Recommended Change 2**

Appendix-7b-settlement-statements---Buchan

Peterhead – P348-364

R2 (Peterhead Keymap (page 356), map 5 (page 361), map 6 (page 362) Amend boundary of R2 area to:

Cover the full extent of the existing decommissioned pipeline corridor between Peterhead Power Station and the jetty in the South Bay Harbour of Peterhead Port. This will allow a connection between the port to the power station for Carbon Capture and Storage related development.

An illustration of this pipeline corridor is provided in *Figure 1* below and is a basis around which to extend the boundary of the R2 designated area north and east to the boundary of the P9 area designated to protect for *'port related activities'*:

#### **Recommended Change 3**

Appendix-7b-settlement-statements---Buchan

St Fergus Gas Terminal – P375

R1 – Amend text to:

For major oil and gas related development within St Fergus Gas Terminal, *including Carbon Capture and Storage (CCS) and hydrogen production.* 

#### Reason for change(s):

#### **Recommended Change 1:**

The ability to import and export carbon dioxide via Peterhead Port and produce hydrogen from natural gas at St Fergus are major components of the Acorn Project, which is a critical project in Aberdeenshire to 'take on the challenges of sustainable development and climate change' and 'to increase and diversify the economy' whilst securing a low carbon future in Scotland and achieving the targets set out in the Climate Change (Emissions Reduction Targets) (Scotland) Act 2019.

This project also offers the opportunity to maximise the economic benefits of a low carbon future to Aberdeenshire.

These additional elements to the Acorn Project, beyond those set out in the current draft of the LDP have been recognised as 'ideas proposed' in relation the National Planning Framework 4.

It is vital that the Aberdeenshire Local Development Plan is able to support low carbon projects, including the Acorn project development to the full extent expected, which has significantly progressed since the adoption of NPF3 in 2014 (which the current definition appears to be based on).

#### **Recommended Change 2:**

As noted above, the ability to import and export carbon dioxide is an important part of maximising the economic benefits and climate change impact of the Acorn Project. This recommended change will ensure that this important element of the Acorn project is protected under the relevant and appropriate policy within the LDP.

#### **Recommended Change 3:**

The recommended change is to provide clarity on the nature of Oil and Gas related developments which could come forward, and be supported, at the St Fergus Gas Terminal. This is important to ensure there is policy clarity for the Acorn project, whilst not precluding any development of existing operations, and the intent of the National Planning Framework to progress CCS and hydrogen production in this location.
