

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



LDP 2021 NN This proposed local development would have a huge and devastating impact our village, this mass increase in housing destroys the greenbelt around the village along with many other things. I object to OP1 and OP2!!.

Reason for change:

Infrastructure: The class 1C road infrastructure around Potterton was not designed to be used by Heavy Goods Vehicles or the increased traffic which, should the developments go ahead, will not be able to cope with. There have already been many near misses on these roads with buses, farm traffic and quarry lorries taking up most of the road and not allowing for any local village people whether it be driving, cycling or walking. There would be excessive traffic and noise and an increased risk to all road users. The roads around Potterton, especially where proposed developments are located, are not suitable for the additional number of houses. The trunk roads which connect to the AWPR were not upgraded and are not set to be upgraded either. They are C class country roads, including single tracks, passing places, blind summits and narrow bends. To increase traffic would be irresponsible.

Sewage: There is insufficient capacity at Balmedie Waste Water Treatment works for all the development in Potterton, Belhelvie, Balmedie and Newburgh included in the proposed LDP. Scottish Water are aware of the high water table and on going drainage and run off issues that the pumping station already can not cope with. Onward proposed housing developments would not be suitable.

Woodland, Greenbelt, Wildlife: I feel the greenbelt should be protected in and around Potterton as it is currently, changing this for housing would be unacceptable and a huge loss, there are also local historical interests which are protected in the area along with ancient woodland in which protected species live, these should also be protected from development.

Education: Local primary school Balmedie is already at capacity and with 5 years is predicted to be 118% capacity. Surely this needs to be addressed before and proposed developments go ahead.

Community engagement: Due to the recent development there has been, understandably, no public meeting with regards to the LDP, I feel that our community deserves more engagement. This potentially has a huge impact on our village and will change its future, and not for the best!!

Previous LDP's: Dated 19th Dec 2016 in the submission of the Report of Examination, planning acknowledged that no modifications to the Green Belt were recommended in Potterton and that infact Potterton was excluded from Strategic Growth area at this time. Since then nothing has changed that should allow growth on this scale to be permitted. Therefore this large scale development should not have been included within the LDP for Potterton.
