

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.



Proposed modification – after Gas Street, include “and a section of Gas Street upgraded”.

**Reason for change:**

Allocations OP2 and OP6 proposed 85 homes and 3.2ha of employment land. Both of the above statements specifically refer to the existing path network leading to Gas Street.

The lower Gas Street section of the path network is part of the existing core path and has a poor surface used as a vehicular access by the residents of Gas Street and only part of this section has a narrow pavement for pedestrians (most of the pedestrians use the carriageway) making this section of the core path dangerous to users.

With the increase of users proposed by the above allocations, this will require the developer of the sites to improve the quality and safety of this section of the path which would be required in conjunction of this private section of the core path.

The proposed modification would allow this to comply with Appendix 8 – Successful Placemaking Design Guidance.
