

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

**This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

## **Reinstatement of Green Belt**

### **Reason for change:**

In previous Local Plans, Potterton had a larger designated Green Belt which appears to have now been drastically reduced without any consultation nor as far as can be seen, any publicly available record relating to the change of designation and the reasons for that change.

The Council has stated in its **LOCAL DEVELOPMENT PLAN 2021, MAIN ISSUES REPORT, JANUARY 2019** that with regard to OP1 and OP2 in Potterton "The site is within the greenbelt, the loss of which could only be justified through strategic land releases." So what justification was given for the removal of OP1 and OP2 from the Greenbelt?

Does the change comply with the Scottish Governments Policy which (in part) states; *"Green belt designation should provide clarity and certainty on where development will and will not take place...Green belt designation should be used to direct development to suitable locations, not to prevent development from happening."*?

The current plan is a complete and wholly unexplained turn-around from the Aberdeenshire Councils previous statements regarding Green Belt around Potterton, a turn-around that removes "certainty" and removes "clarity" and will destroy the character of Potterton. There are no nationally important or essential developments, nor any national priority that warrants removal of Green Belt status to parts of Potterton nor is there any strategic need for the Development as proposed in the LDP.

The Council themselves recently criticised Aberdeen Council for their lack of protection of Green Belt at a development site at Leggart Brae, making a formal representation requesting that *"the site is removed from the LDP"* over what it describes as the *"unnecessary loss of green belt land"*. I expect Aberdeenshire Council will now look to apply the same criteria within their own Council area on the same basis and remove the Potterton Green Belt development sites from the LDP.

On that basis, the LDP for Potterton should not be implemented, in particular for OP1 & OP2 but also for the Green Belt around the village which should be reinstated in its entirety to comply with not only Scottish Government Policy, but also previous statements provided by the Council and the values and policies the Council proclaims that it follows and implements and which it expects other Councils to also follow.
