

# PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

## **This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.**

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

**Removal of Potterton from statement**

**Reason for change:**

The statement at 5.14 implies a link between Potterton and the Energetica Corridor and thus justification for the LDP;

*“Additional smaller developments in Newburgh, Foveran, Bellhelvie and Potterton are included to promote the Energetica Corridor”*

Potterton is NOT in the Energetica Corridor, indeed, the statement under Vision on page 476 of Appendix 7c Settlement Statements Formartine correctly states that Potterton “....is outwith the Aberdeen to Peterhead Strategic Growth Area”

The inclusion of Potterton at Para 5.14 must be removed to provide clarity of the exact status of Potterton in that it is NOT in the Strategic Growth Area and it is therefore inappropriate to imply that it is or that it is somehow linked to it for the purposes of the LDP.
