As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

I refer to Aberdeenshire Council's LDP – specifically the Section and Policies on Natural Heritage and Landscape – Section 10 Policy E1 Natural Heritage Nature Conservation Sites E1.1:

"We will not allow new development where it may have an unacceptable adverse effect on a nature conservation site designated for its biodiversity or geodiversity importance....

Furthermore, E1.4 identifies the importance of Local Nature Conservation Sites stating:

"...The proposal's public benefits must clearly outweigh the nature conservation value of the site."

Reason for change:

As a member of Protect Banchory Devenick I applaud the current stance adopted by Aberdeenshire Council with regard to the potential environmental issues that impact on the area.

The threat from housing development on the land south of Deeside Braes and to the west of the Den of Leggart on land that was originally assessed by Planning Officers of Aberdeen Council as "undesirable" but is now identified as a "housing opportunity" is of great concern.

It is to be hoped that Aberdeen Council review this decision to build homes in this location and align with the recommendations of their counterparts in Aberdeenshire Council.

The value and importance of Banchory Devenick from a Natural History viewpoint cannot be underestimated. The diversity and volume of faunal records held by the North East Scotland Biological Records Centre (NESBReC) for Banchory-Devenick reflect its importance. This green wedge of land so close to the outskirts of Aberdeen has acts as a conduit for a rich diversity of birds, mammals and invertebrates. Important changes in recent years is the return of Red Squirrels and colonisation by Pine Martens These in themselves are of significant importance but considered along with a significant population of Barn Owls, Badgers, Roe deer, etc

The presence of this stretch of woodland cannot be underestimated when considering the health of the local community and residents of Aberdeen. As a resident of Leggart Terrace I was able to see the numbers of people who visited Banchory -Devenick on a daily basis in order to walk and enjoy the series of pathways leading to Tollohill Wood. Many individuals expressed the view that made the "lockdown" regime bearable.

In conclusion, I thank Aberdeenshire Council for upholding important policies in order to keep Banchory-Devenick, Aberdeenshire, the fantastic place that it is and for safeguarding the rich natural environment that is so important to all of us.
