

PROPOSED ABERDEENSHIRE LOCAL DEVELOPMENT PLAN 2020 RESPONSE FORM

As part of the production of the Local Development Plan, a 'Main Issues Report' was published in January 2019. The responses from these consultations have helped to inform the content of the Proposed Local Development Plan ("the Proposed Plan").

The Aberdeenshire Local Development Plan will direct decision-making on land-use planning issues and planning applications in Aberdeenshire for the 10-year period from 2021 to 2031. The Proposed Plan was agreed by Aberdeenshire Council in March 2020 as the settled view of the Council. However, the Proposed Plan will be subjected to an independent examination and is now open for public comment.

This is your opportunity to tell us if anything should be changed in the Proposed Plan, and why.

When writing a response to the Proposed Plan it is important to specifically state the modification(s) that you would wish to see to the Plan.

This is the only remaining opportunity to comment on the Proposed Plan. The reasons for any requested changes will be analysed and reported to Scottish Ministers. They will then appoint a person known as a Reporter to conduct a public examination of the Proposed Plan, focusing particularly on any unresolved issues and the changes sought.

Ministers expect representations (or responses) to be concise (no more than 2000 words) and accompanied by limited supporting documents. It is important to ensure that all of the information that you wish to be considered is submitted during this consultation period as there is no further opportunity to provide information, unless specifically asked.

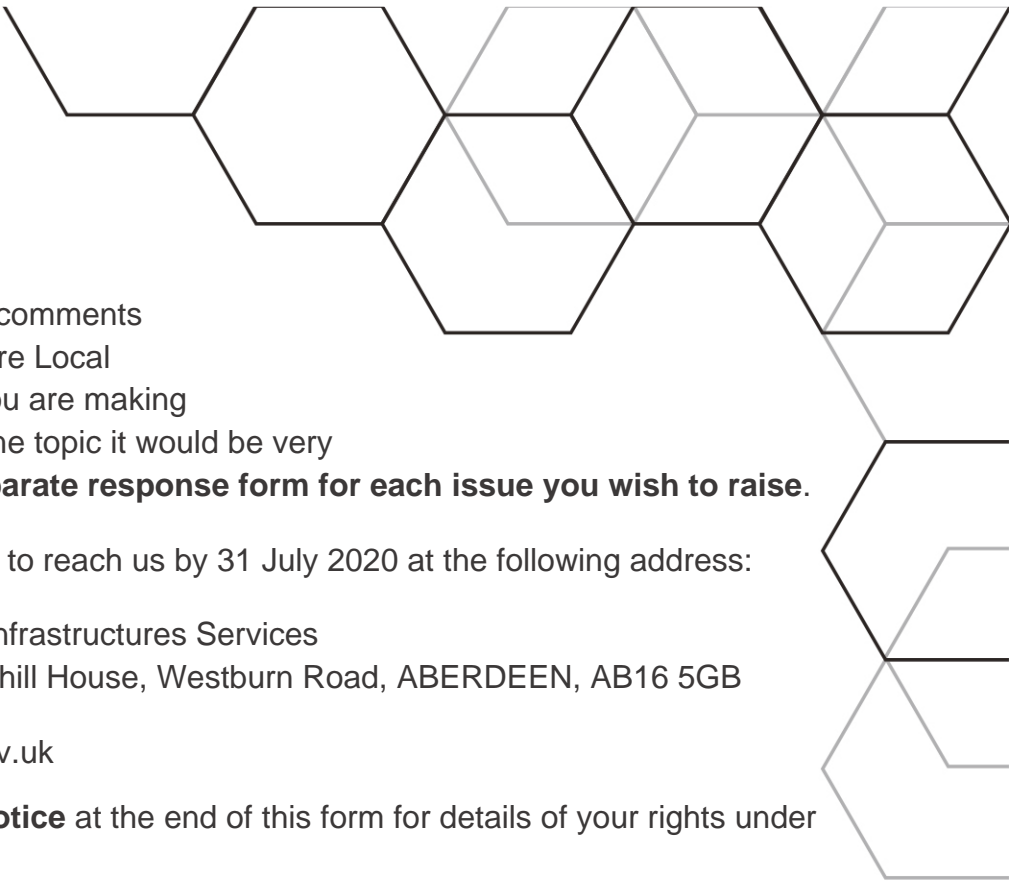

Appendix 7D – Garioch Settlements, Inverurie & Port Elphinstone

Change of Reserved/Protected status of R2 (Extension to Ury Riverside Park) to Preferred Option/ Allocated Site to allow for a Mixed Use Type development including Mixed use of 109 homes and a Riverside Park.

Reason for change:

Bid reference number GR137 was submitted for a mixed-use development of 109 houses and land to extend the Uryside Riverside Park. This bid has not been preferred by officers and yet the R2 site has been classified as Protected for an extension to Uryside Park only.

Firstly the landowners have not accepted this & would only consider doing so in conjunction with some form of development on part of the site out with the Flood Plain.

Therefore changing of the proposed site to Mixed Use Preferred Option will allow for the expansion of Uryside Park whilst at the same time providing a small housing development that could contribute proportionally towards the required improvements of the infrastructure network as well as the Howford Bridge crossing on the B90001 over the River Ury.

There is scope for a small-scale development with an indicative capacity of 109 homes including 27 affordable homes within the central part of the site on an enabling development basis to allow for footpaths and cycle connectivity to be made between the riverside park and development sites at OP3 and BUS1 (865).

The design of the development shows two points of access with the development located in the northern part of the site. Land for the Uryside Riverside Park would be protected with access to it also shown. The flood plain area would be protected and areas for enhanced biodiversity shown adjacent to this. The parkland offers natural environment enhancement.

It is understood that none of the potential routes for the A96 dualling project would prejudice the delivery of the site at Howford. The local road network is already being assessed by the Council and contributions could be agreed for any local improvements. The location and size of this development, alongside the benefit of delivering a large area of parkland should be further considered.

The site is well situated in location to the ongoing Uryside development OP4 and would provide the additional benefits required to supplement this development.

Due to the already ongoing development at Uryside (OP4) it makes the Main Issue Report argument for protecting due to the presence of Prime Agricultural land no longer relevant. The current agricultural land is used to support a large-scale piggery & sheep farm. Due to the sites now proximity to the large development at Uryside it would make maintaining this agricultural land extremely problematic for the local community due to heavy requirement for spreading of organic manures such as slurry. The requirement to transport slurry tankers in & out of this site which is now sandwiched between Inverurie developments on three sides would result in heavy complaints from the public. This continuous & cyclic process of slurry spreading will also have an impact on the current Uryside Park causing a deterrent for the public due to proximity to this farm land smell.

Based on the above facts i strongly requested that the site is allocated in the Proposed LDP which will provide benefits to all, by way of Uryside Park extension, Small scale development & infrastructure improvements.
